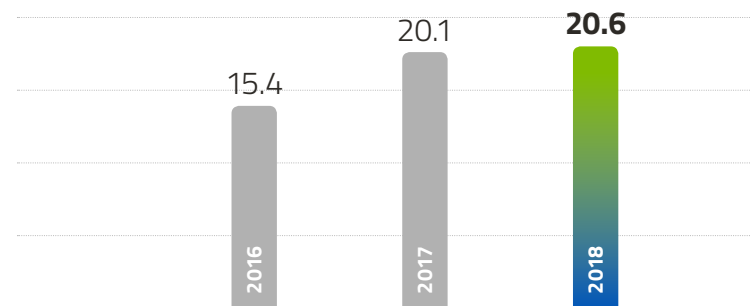

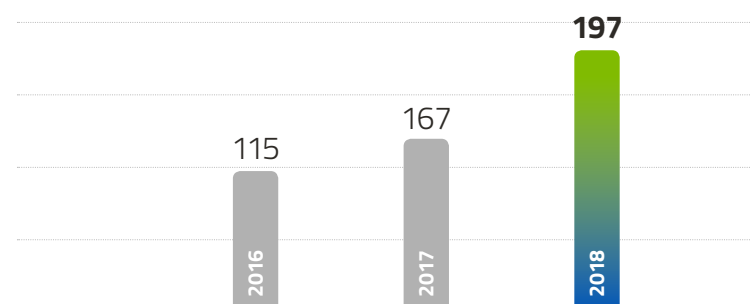

## A FIRST IN FINTECH: FINBERG

Fibabanka launched Finberg Araştırma Geliştirme Danışmanlık Yatırım Hizmetleri Anonim Şirketi (“Finberg”), an investment and financial technology venture. Achieving a first in the Turkish banking industry, Finberg was founded to promote entrepreneurship and financial technologies. Aiming to partner with medium-size companies and offer consultancy services in areas with high growth potential, Fibabanka provides financing and added value to enterprises in the fields of mobile payment, income-expense monitoring and money transfer.

The main purpose in establishing Finberg is to offer customers both conventional banking products and new products emerging from the combination of financial services and technology. Finberg is designed to reach new customers and extend the Bank’s existing customers portfolio with such technological products, providing services to them with the right products. Furthermore, other purposes include minimizing the high costs and long timelines posed by the provision of products and services, while eliminating the challenges associated with accessing customer information and incorrect information, as encountered in conventional banking products.

To support the growth of FinTech and the retail ecosystem, in 2018, Finberg made investments in Bizim Hesap A.Ş., an online operational accounting reporting program enabling rapid and easy e-invoice integration; Garaj Sepeti A.Ş., which offers a software product that brings together auto showrooms and auto appraisers on a digital platform; Birleşik Ödeme Hizmetleri A.Ş., which holds licenses for payment services and e-money; and, further in the field of financial technologies, the venture capital fund Revo Capital Fund I.B.V., which invests in startups operating especially in areas such as information services, machine-to-machine communication and payment systems.

Continuing discussions with new entrepreneurs as well, Finberg will facilitate the lives of entrepreneurs and continue to support all projects that will provide added value to the banking system.

### Partnerships with Retail Companies

Fibabanka continued to offer loans to consumers purchasing products at the sales points of partner companies, as part of its cooperation with leading retail companies in Turkey.



### Loan Extended by Fibabanka to Micro-Enterprises: EaSI Program

Fibabanka signed a loan guarantee agreement with European Investment Fund (EIF) to support micro-enterprises as part of the EU Programme for Employment and Social Innovation (EaSI). The collaboration aims to support by nearly 5,000 micro-enterprises through the utilization of loans amounting to EUR 20 million in total, under favorable loan conditions.

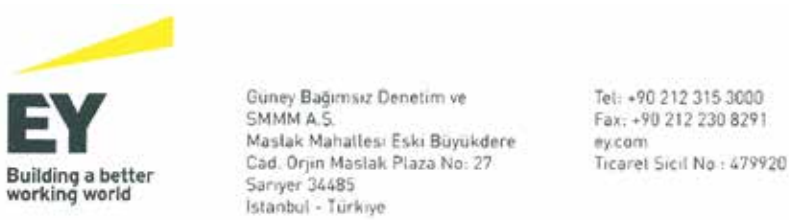

INDEPENDENT AUDITOR'S REPORT ON THE ANNUAL REPORT OF THE BOARD OF DIRECTORS

To the General Assembly of Fibabanka A.Ş.

1) Qualified Opinion

We have audited the annual report of Fibabanka A.Ş. (the “Company”) and its subsidiaries (the “Group”) for the period of January 1, 2018 and December 31, 2018.

In our opinion, except for the effect of the matter described in the Basis for Qualified Opinion, the consolidated financial information provided in the annual report of the Board of Directors and the discussions made by the Board of Directors on the situation of the Group are presented fairly and consistent, in all material respects, with the audited full set consolidated financial statements and the information we obtained during the audit.

2) Basis for Qualified Opinion

As explained in our opinion dated 8 February 2019 on consolidated financial statement for the period between 1 January – 31 December 2018, consolidated financial statements as at December 31, 2018 include a general reserve which does not meet the relevant criterias in TAS 37 “Provisions, Contingent Liabilities and Contingent Assets” for possible risks provided by the Bank Management for possible results of the circumstances which may arise from possible changes in the economy and market conditions amounting to TL 65,000 thousands out of which TL 55,500 thousands and TL 9,500 thousands were provided during previous years and within the current period respectively with a current year deferred tax amounting to TL 14,300 thousands. As a result of accounting of aforementioned provision in financial statements, “Extraordinary Reserves” and “Current Period net Profit or Loss” are presented as TL 388,400 thousands and TL 197,014 thousands as of December 31, 2018, respectively.

We conducted our audit in accordance with Independent Auditing Standards (InAS) which are part of the Turkish Auditing Standards as issued by the Public Oversight Accounting and Auditing Standards Authority of Turkey (POA). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Annual Report section of our report. We are independent of the Group in accordance with the Code of Ethics for Independent Auditors (Code of Ethics) as issued by the POA, and we have fulfilled our other ethical responsibilities in accordance with the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

3) Our Auditor’s Opinion on the Full Set Consolidated Financial Statements

We have expressed a qualified opinion in our auditor’s report dated February 8, 2019 on the full set consolidated financial statements of the Group for the period of January 1, 2018 and December 31, 2018.

4) The Responsibility of the Board of Directors on the Annual Report

In accordance with Articles 514 and 516 of the Turkish Commercial Code 6102 (“TCC”) and communique on “Regulation on the Principles and Procedures Concerning the Preparation of and Publishing Annual Report by Banks,” the management of the Group is responsible for the following items:

- a) Preparation of the annual report within the first three months following the balance sheet date and submission of the annual report to the general assembly.
- b) Preparation and fair presentation of the annual report; reflecting the operations of the Group for the year, along with its financial position in a correct, complete, straightforward, true and honest manner. In this report, the financial position is assessed according to the consolidated financial statements. The development of the Group and the potential risks to be encountered are also noted in the report. The evaluation of the board of directors is also included in this report.

c) The annual report also includes the matters below:

- Subsequent events occurred after the end of the fiscal year which have significance,
- The research and development activities of the Group,
- Financial benefits such as salaries and bonuses paid to the board members and to those charged governance, allowances, travel, accommodation and representation expenses, financial aids and aids in kind, insurances and similar deposits,
- Other issues determined in accordance with “Regulation on the Principles and Procedures Concerning the Preparation of and Publishing Annual Report by Banks” published in official gazette no.26333 dated November 1, 2006.

When preparing the annual report, the board of directors takes into account the secondary legislative arrangements published by the Ministry of Customs and Trade and related institutions.

5) Auditor’s Responsibilities for the Audit of the Annual Report

Our aim is to express an opinion, based on the independent audit we have performed on the annual report in accordance with provisions of the Turkish Commercial Code and communique on “Regulation on the Principles and Procedures Concerning the Preparation of and Publishing Annual Report by Banks” published in official gazette no.26333 dated November 1, 2006, “Regulation on the Procedures and Principles for Accounting Practices and Retention of Documents by Banks” published in official gazette no.26333 dated November 1, 2006 and other regulations on accounting records of Banks published by Banking Regulation and Supervision Agency (BRSA), circulars, interpretations published by BRSA and “BRSA Accounting and Financial Reporting Legislation” which includes the provisions of Turkish Financial Reporting Standards (TFRS) for the matters which are not regulated by these regulations, on whether the consolidated financial information provided in this annual report and the discussions of the Board of Directors are presented fairly and consistent with the Group’s audited consolidated financial statements and to prepare a report including our opinion.

The independent audit we have performed is conducted in accordance with InAS and the “Communique on Independent Audit of Banks.” These standards require compliance with ethical provisions and the independent audit to be planned and performed to obtain reasonable assurance on whether the consolidated financial information provided in the annual report and the discussions of the Board of Directors are free from material misstatement and consistent with the consolidated financial statements.

become the "Most Loved Bank of Turkey" while improving its service quality based on the needs and expectations of customers. Fibabanka also continues to diversify its products and services for customers via its subsidiaries, Fiba Portföy Yönetimi A.Ş. and Finberg.

## A Brief History of the Bank

The Bank's history dates back to Sitebank A.Ş. The Bank was transferred to SDIF with its shares thereafter being sold to Novabank in 2002. The name of the Bank was changed to Bank Europe Bankası A.Ş. in 2003. In 2006, shares owned by Novabank S.A. were transferred to Millennium BCP; the Bank's name was changed to Millennium Bank A.Ş.

After necessary permissions were obtained upon Fiba Group's application to the Banking Regulation and Supervision Agency, Millennium Bank A.Ş. joined Fiba Group on December 27, 2010. At the time, the name of the Bank was changed to Fibabanka A.Ş. Fibabanka commenced providing banking services upon the

share transfer from Millennium Bank A.Ş. to Credit Europe Bank N.V., one of Fiba Group's major investments based in the Netherlands. In 2012, the shares of the Bank held by Credit Europe Bank N.V. were purchased by Fiba Holding A.Ş. In 2015, International Finance Corporation (IFC) and European Bank for Reconstruction and Development (EBRD), two global development institutions invested in the Bank, each acquiring a 9.95% stake through a capital increase. In 2016, TurkFinance B.V. (Abraaj), a private equity investor, acquired a 9.95% stake in the Bank. As the sale of shares to Abraaj was consummated via an issuance of new shares, the shares of IFC and EBRD in the Bank were reduced to 8.96% each. Following these investments, the Bank's capital increased to TL 941,160,553.25. Fiba Group continues to retain the majority stake in Fibabanka, with 71.57% of the Bank's share capital as of year-end 2018.

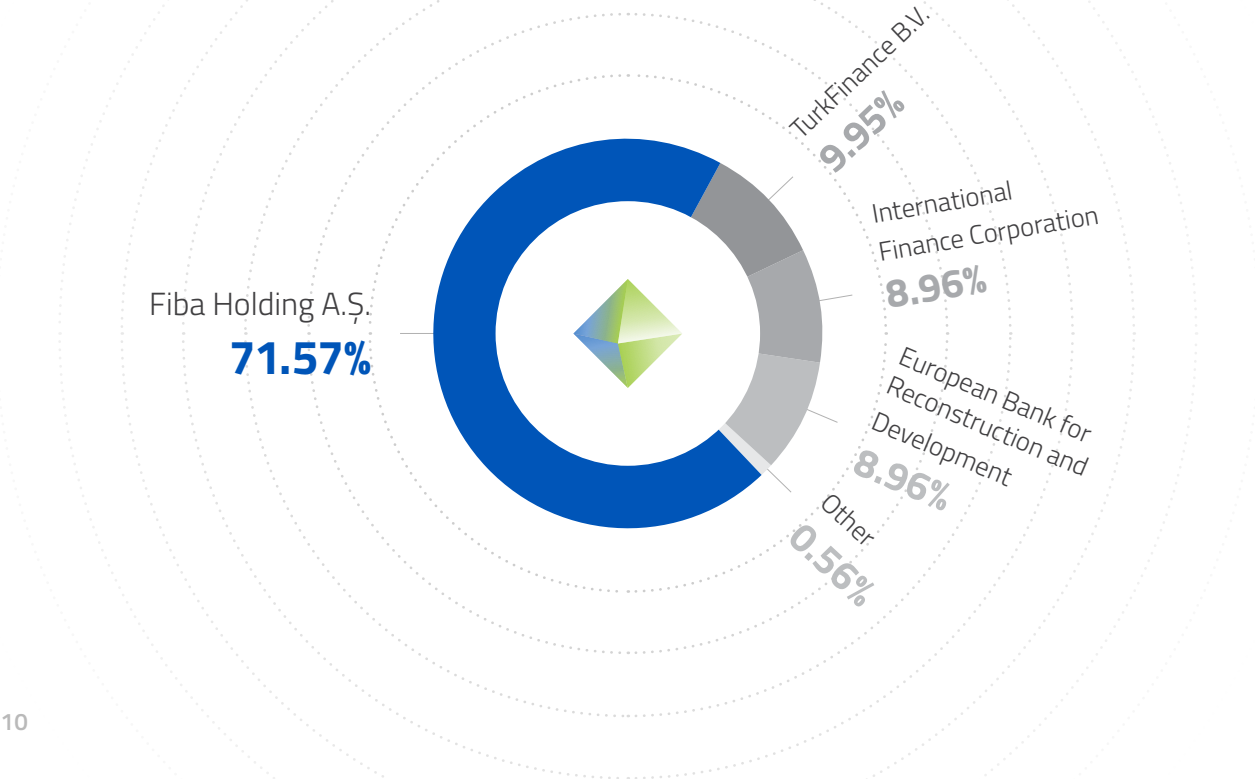

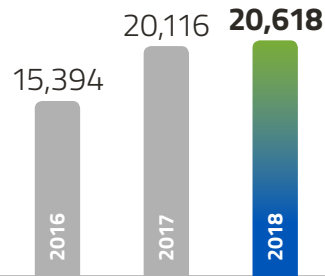

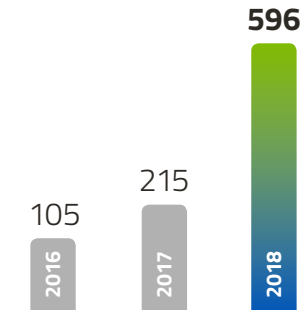

MESSAGE FROM

Esteemed Stakeholders,

The global markets and Turkey welcomed 2018 on a positive note. The Turkish lira appreciated during first quarter of 2018 while TL interest rates declined, due to positive atmosphere prevailing across all asset classes. In particular, Eurobond issuances saw high demand in the banking industry, as a result of increasing risk appetite starting from the beginning of January. During this period, our Bank tapped the capital markets with a five-year Eurobond which drew great interest from investors; bonds worth USD 300 million were issued with an interest rate of 6%.

The implementation of the interest rate hike policy of the US Federal Reserve (Fed) caused capital outflows from the emerging markets. Meanwhile, in Turkey, fluctuations in the Turkish lira peaked in the second half of 2018. Monthly volatility that pushed the Turkish lira to unprecedented levels, had spillover effects across the economy. All of these factors caused inflation to reach a fifteen-year peak. Inflation jumped to 25% in October 2018, before slowing somewhat to end

the year at about 20%. In parallel with these developments, deposits, bonds and swap interest rates increased significantly for a while. Timely intervention by the Banking Regulation and Supervision Agency (BRSA) and the Central Bank of the Republic of Turkey (CBRT), especially, combined with measures taken by the government to stabilize the economy, paved the way for reduced risks during this period. Starting to normalize from mid-October, improved Turkey-US relations also helped balancing markets, with interests rates trending downward and retreating from their peak levels.

Volatile market conditions also affected economic growth figures; GDP growth declined in each successive quarter of 2018. Turkey's economy contracted significantly, especially from the third quarter of 2018, which impacted unemployment rates in particular. Thanks to declining oil prices, the current account deficit dropped to USD 33.9 billion in October, down from USD 58.2 billion in May. The country's current account deficit is projected to conclude 2018 at USD 27 billion, 3.7% of GDP.

Deterioration in the macroeconomic indicators also had an impact on the banking sector. Problems in the balance sheet of real sector companies, as well as cash flow problems, were reflected on banks' balance sheets. The non-performing loan ratio started to rise from third quarter, when growth declined notably. For the banking sector, these risks are expected to persist throughout the first half of 2019.

The total assets of the Turkish banking industry grew 19% to TL 3.9 trillion as of year-end 2018. Growth in loans was limited to 14%, while the non-performing loan ratio was 3.9%. In 2018, the sector recorded net profit of TL 53.5 billion, with a capital adequacy ratio of 17.3%.

Our Bank continued to support the real sector during this period, while focusing on asset quality, sustainable profitability and efficiency. With this approach, we concluded the year successfully in accordance with our projections and targets. We closed fiscal year 2018 with assets amounting to TL 20.6 billion and total net profit of TL 196.7 million up 18% year-on-year. Meanwhile, our return on equity was 15.7% and the capital

In 2018, Fibabanka strengthened its robust capital structure as the Bank's capital adequacy ratio stood at 19.5%.

adequacy ratio was 19.5%. During the year, in order to offer innovative services to our customers and enhance the quality of those services, we injected momentum into operational processes by investing in financial technologies, and forming project and product driven agile teams. With these efforts, we are taking pioneering steps in the digital transformation journey of our Bank.

In 2019, the Turkish banking sector and Fibabanka will aim to achieve prudent and cautious growth which shores up its asset quality, while pursuing agility- and efficiency-driven operational and technological improvements.

## MESSAGE FROM THE GENERAL MANAGER

2018 marked a number of achievements, where we initiated numerous pioneering projects and business partnerships in the banking industry, in line with our goals and expectations. We managed and maintained our financial stability by prioritizing asset quality, sustainable profitability and efficiency amid market fluctuations.

Our Bank reported total assets of TL 20.6 billion as of 31 December 2018. Our net profit was TL 196.7 million and TL 197 million on solo and consolidated basis respectively, up 18% compared to the previous year. We achieved positive results with our innovative products and elevated service quality on our digital transformation journey. As a major testament to the support we extend to our state's economy and customers, gross loans accounted for 71% of our total assets in 2018. Our total deposits stood at TL 11.3 billion. We recorded a return on equity at 15.7% and a capital adequacy ratio at 19.47%, healthily exceeding the target ratio of 12%.

In an era when customer expectations and needs change rapidly, the banking industry, like all leading industries, is undergoing a similar rapid digital transformation across business models and operational processes. At Fibabanka, we undertook many important projects driven by transformation by boosting our financial

technology investments in 2018. We ensured that our operational processes gained momentum by establishing product- and project-oriented agile teams.

By continuing to generate value added for our country's social and economic development, we established “Finberg” – a first in the banking industry – as an investment and financial technology venture. We started to make investments, via Finberg, in order to expand and bolster the new initiatives of artisans and SMEs across the FinTech and retail sectors. Our Bank's priority goals for the upcoming year also include partnering with medium-size companies with high growth potential and offering them consultancy services via Finberg. We aim to extend financing and value added to such enterprises in areas such as mobile payment, money transfers, P&L follow-ups, financial reporting and robo-advisory.

In 2018, driven by our diversification goal, we focused our efforts on our customers' retail financing needs, in addition to conventional banking needs. To this end, we concluded a year where we established important partnerships and strengthened our existing relations. Adopting the motto “Agile thinking, agile solutions” and personal approach to customer service, we began to deliver various products and services to our customers at their location

ranging from insurance to loans and from invoice collection to deposit products. We restructured our direct sales teams and Call Center to offer innovations in customer experience and enhance customer satisfaction.

As a major component of our diversification strategy, we increased the share of our Kiraz Account product – which combines the freedom of a checking account with the yield of a deposit account – within total deposits. In 2018, we added the corporate client segment to the Kiraz Account product, which can be opened in both TL and USD. The Kiraz Account will continue to be among the priority products in the coming periods as part of our Bank's diversification objective.

In 2018, we signed a loan guarantee agreement with the European Investment Fund (EIF), as part of the EU Programme for Employment and Social Innovation (EaSI). Being the first and only bank in Turkey under EaSI program, Fibabanka aims to help strengthen the assets and expand the businesses of our artisans and SME customers. Starting from 4<sup>th</sup> quarter of 2018, we started to extend financing to micro-enterprises, seeking to start new business or grow their own business. This agreement will cover a loan portfolio of EUR 20 million for around 5,000 micro-borrowers who will be able to benefit favorable loan conditions.

We initiated another first in the sector by maintaining our entrepreneurial and innovative approach across all areas. Tapping into the “Transfer on Duty” service, we enabled our customers to transfer money between the banks included in the system.



This year we issued our debut five-year Eurobond, amounting to USD 300 million, in the global markets – achieving a significant first in international funding. As one of the first issuances of 2018, the transaction attracted demand mainly from UK and other European based investors. As a result of oversubscription, we concluded the issuance with a fixed interest rate of 6%, lower than the interest rate announced initially.

We launched yet another project that is a first in the sector by maintaining our entrepreneurial and innovative approach across all areas. Tapping into the “Transfer on Duty” service, we enabled our customers to transfer money between the banks included in the system on a 24-hour, seven day per week basis.

We also boosted our investments in human resources, believing that customer satisfaction is achieved with satisfied employees. As a result of these investments, our employee engagement and satisfaction level increased by 6 points in 2018, compared to the previous year. Our excellence in human resources was recognized with a total of three awards, including the “Employee Engagement Award” from AON Hewitt; “Respect for People Award” from Kariyer.net; and a Bronze award in the category of “Achievement in Workforce Development and Learning” at the Stevie Awards. We will continue our efforts with an innovative and prudent approach to achieve high employee engagement and satisfaction.

I would like to sincerely thank our esteemed colleagues, who contributed to our Bank's successful performance in 2018; our customers, who continued to choose us; and all our stakeholders, who give us strength with their collaborations.

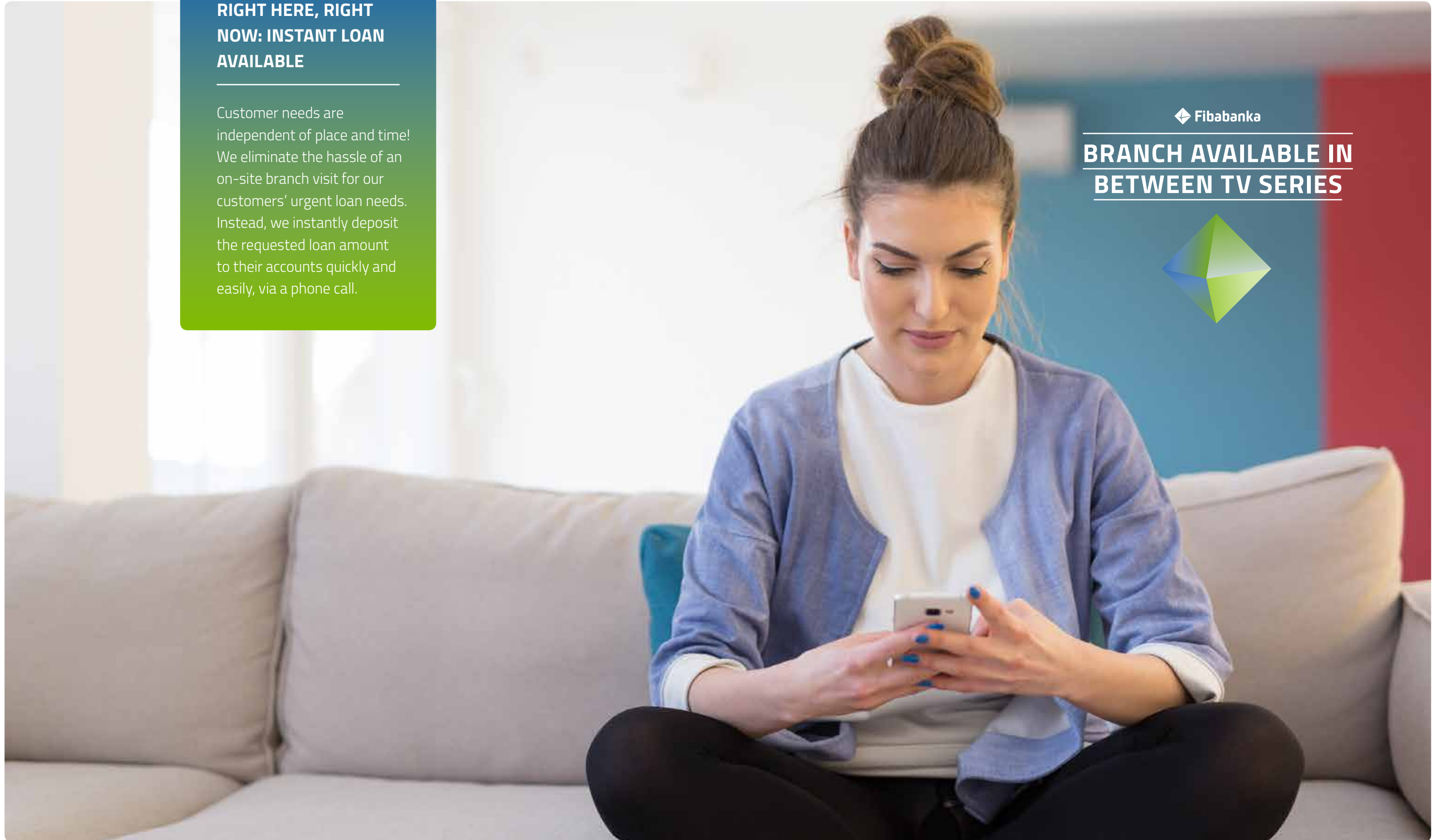
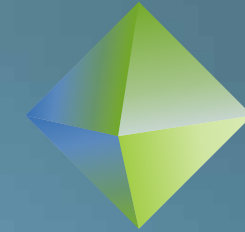

In 2019, Fibabanka will continue to extend significant support to the Turkish economy by financing the activities and investments in the real sector, in line with its customer-focused approach across the Corporate Banking segment.

Corporate Banking

Corporate Banking in Fibabanka provides products and services to clients with an annual turnover of TL 250 million or more, via its branches. Services offered by Fibabanka for corporate clients include cash and non-cash loans (TL and foreign currencies), as well as corporate financial consulting on investment financing; mergers & acquisitions, and project finance loans. Corporate Banking also offers solution proposals for financing foreign trade, treasury products to mitigate interest and exchange rate exposure, corporate finance services, and deposit and cash management services. Offering a solution-driven approach to its Corporate Banking clients, Fibabanka

attained effective results in 2018 as well. Amid volatility in 2018, Corporate Banking continued its customer-focused efforts by means of proper risk management. During this period, corporate clients’ share in check collection volume expanded by 103% and their tax payment share rose by 442%. As for resources, demand deposit average rose by 50% YoY, and commission earnings by 55%. In 2019, Fibabanka will continue to extend substantial support to the Turkish economy by financing the activities and investments of the real economy, in line with its customer-focused approach across the Corporate Banking segment.

Cash Management and Foreign Trade

With a focus on offering rapid and efficient products to simplify customers’ lives, Fibabanka carried on operations driven by its motto of delivering the best banking solutions to customers in the area of Cash Management and Foreign Trade in 2018.

Fibabanka took breakthrough steps in Cash Management and Foreign Trade in the 2018 fiscal period. Within this framework, the number of customers receiving brokerage services for invoice payments rose seven-fold, compared to the previous year. The unified tax product which was launched to offer convenience for special consumption tax (ÖTV) payments, raised the Bank’s market share from 14.5% to 25%. As one of the two banks with the highest market share in this field, Fibabanka attained a 120% YoY increase in tax collection volumes in 2018. Ensuring widespread use of Customs Duty Payment via SMS product, which facilitates customs duty payments, the Bank collected 86% of the total customs duty through this product.

The Bank continued to transfer funds to the real sector via the Supplier Finance System, specially designed to assist clients with a large network of suppliers in working capital management and enable such suppliers to access finance more quickly.

The Bank increased its market share for drawing check volume to 1.93%.

In 2018, Fibabanka redesigned the MT940 Electronic Statement solutions in order to offer end-to-end holistic services to customers and created an infrastructure that can generate flexible and extensive statements to meet varied accounting integration needs of customers in the best way. Additionally, it deployed the Web Service and Account Activities product, which transmits instant updates to customers’ ERP systems, helping them save money/time in business processes.

Achieving a first in the banking sector in terms of digital transformation and offering uninterrupted services to customers, Fibabanka introduced Transfer on Duty service that enables Turkish lira transfers across banks on a 24/7 basis, including weekends.

Commercial Banking

Fibabanka’s Commercial Banking business unit offers rapid and streamlined financial solutions for all the banking needs of firms with an annual turnover between TL 25 million and TL 250 million. These services include cash and non-cash loans and deposit transactions; foreign trade finance; treasury transactions for currency and commodity fluctuations; long-term finance such as HPP, WPP and factory investments; and cash management products and services that simplify firms’ day-to-day operations. As of the end of 2018, Fibabanka delivers rapid financing

solutions in the Commercial Banking segment, customized for customers by analyzing varying market conditions with a total of 29 branches, including 17 Istanbul-based branches, across 11 cities. Thanks to the consistent operations carried out by Fibabanka in this field, the total number of active clients in the Commercial Banking segment reached 2,917. Driven by Fibabanka’s goal of being the most preferred bank of Turkey which is inclusive, a jump of 62% took place in check volumes for which the Bank offers brokerage services for clients’ payments, and a 110% increase in tax payments was attained in the Commercial Banking segment. Taking competition a step ahead with innovative products, Fibabanka grew by 63% in the number of commercial clients using unified tax services in 2018. With Customs Duty via SMS, an outstanding service in the sector, the share of Commercial Banking in the overall segments of the Bank accounted for up to 46% in terms of the number of clients.

Launched by Fibabanka in May 2017, FibaTarife brings together the commission fees and expenses paid by customers in a single package, enabling clients to choose the option that best fits their business volume. Introduced to customers in the Commercial Banking segment in 2017, The number of FibaTarife usage increased by 35% as of the end of 2018.



## SME AND ENTERPRISE BANKING

The volume of cash loans extended to and utilized by artisans and SMEs in 2018 totaled TL 1.3 billion.

Fibabanka launched instant loan services for artisans and SMEs in SME and Enterprise Banking via the Automated Scoring and Decision System, eliminating the need to visit a branch.

The core field of activity in SME and Enterprise Banking at Fibabanka is to boost the production, investment and employment activities of artisans and SMEs, and to provide financial solutions for them, as they are the backbones of Turkish economy. Fibabanka SME and Enterprise Banking meets the financial needs of companies with an annual turnover of up to TL 25 million. To this end, it offers products and services with competitive advantages for artisans and SMEs.

The total number of active Fibabanka clients in the field of SME and Enterprises reached 26 thousand. More than 19 thousand of its active clients are loan customers. Fibabanka continued to extend further support to the real sector and the volume of cash loans extended to and utilized by artisans and SMEs reached TL 1.3 billion in 2018.

#### A Tool for Artisans to Meet Their Cash Needs: FibaPratik

Fibabanka introduced FibaPratik, a service addressing the needs of artisans in the SME segment, across seven different products; these applications can be performed via SMS or online. Thanks to this product, SMEs can utilize a loan limit of up to TL 60 thousand across several products (check, card, loan, etc.) just with one application.

#### Bespoke Solutions for the Day-to-Day Banking Transactions of Artisans and SMEs: FibaTarife Packages

Launched by Fibabanka, FibaTarife brings together the commission fees and expenses paid by customers in a single package, enabling clients to choose the option that best fits their business volume. A total of 17,669 customers were extended FibaTarife packages in 2018, enabling them to perform transfers, EFT and Swift transactions, as well as Check and Bill Collection transactions, via a single package.

#### The First and Only Turkish Bank to Participate in EaSI

Fibabanka signed a loan guarantee agreement with the European Investment Fund (EIF) to support micro-enterprises as part of the EU Programme for Employment and Social Innovation (EaSI). The collaboration aims to support approximately 5,000 micro-enterprises through utilization of EUR 20 million in loans, at suitable borrowing conditions.

#### Loans Extended to SMEs via Business Partnerships

Fibabanka launched instant loan services for artisans and SMEs in the field of SME and Enterprise Banking via the Loan Assessment and Extension System with the business partners, thus eliminating the need to visit a branch.

#### 24/7 Sales Opportunity for Member Merchants

Utilizing the Virtual POS product, Fibabanka is able to offer products to customers on a 24/7 basis, quickly and easily, via member merchants, Internet Banking or Mobile Banking channels. Alternative payment methods and POS solutions are delivered to firms engaged in the e-commerce sector, through Virtual POS.

#### AGRICULTURAL BANKING

##### FibaTarım App Accessible to All Farmers

Fibabanka offers banking services to customers with operating revenues in agriculture, including farmers, agricultural enterprises, unions and cooperatives, through its Agricultural Banking segment. Additionally, FibaTarım was launched as an app, available to every farmer, whether or not they are Fibabanka clients. FibaTarım also enables users to track location-based weather forecasts, along with agriculture-related news and fruit market and stock exchange prices.

##### Always at Farmers' Disposal with TarımKart

Fibabanka introduced TarımKart in 2018 to meet the banking needs of customers with revenues in agricultural production. TarımKart holders can utilize their allocated agricultural loan limits for their agricultural production needs, either in cash at Fibabanka branches and ATMs or via contracted merchants with agricultural POS membership, whereby they can enjoy benefits of interest-free period and make repayments in harvest maturities that fit their production periods. The number of TarımKart reached 2,705 and agricultural loan volume realized as TL 262 million in 2018.

Fibabanka introduced TarımKart in 2018 to meet the banking needs of customers with revenue in agricultural production.

# RETAIL BANKING

With its “Instant Loan” service, Fibabanka creates rapid and streamlined financial solutions across the retail sector to meet consumers’ needs with a wide array of products, particularly technology products.

By effectively tapping into partnerships, up to 400 thousand new prospects were turned into new customers in 2018.

**400 Thousand New Customers**

The products and services in Fibabanka’s Retail Banking segment are designed to meet all the financial needs of customers. Powered by the principle of continuous development, and consistently improving its service infrastructure, Fibabanka offers services to customers in the Retail Banking segment via branches, Call Centers, Internet Banking, its Mobile Banking app and its newly-structured non-branch channels.

## Nearly 400 Thousand New Retail Customers in 2018

Driven by its diversification goal, which is among the fundamental components of its business model, Fibabanka took breakthrough steps in the field of Retail Banking in 2018. Establishing major business partnerships during the year, the Bank increased the number of its customers significantly through diversification. While the number of stores/contact points exceeded 2,000 as a result of these new partnerships, the new customers acquired reached 400 thousand. Fibabanka aims to build new networks with the substantial experience it has gained with partnerships.

Armed with its digital focus and technical infrastructure, Fibabanka ensures that systems can be planned and realized rapidly, and provides capabilities that can quickly deploy new systems. In this way, the varying financial needs of both clients and business partners are responded to quickly and consistently. Having developed effective projects very quickly after closing deals with its business partners, Fibabanka became a financial preference for both its business partners and its clients.

## Fibabanka Direct Sales Service

In 2018, Fibabanka took a major step by restructuring its Direct Sales team. Thanks to this team, prospects can become Fibabanka customers, and instantly access any product they need, without visiting any branch. The Direct Sales Team expands the Bank’s customer base by making sales via tablets, through onsite visits to customer locations that currently lack Fibabanka branches. In this manner, customers can perform banking transactions comfortably, wherever they are located, meeting their financial needs without losing time in the rapidly-changing economic environment. Fibabanka’s Direct Sales Team provides a wide range of services, including insurance, loans and deposit products, including Kiraz Account.



## A Demand Deposit Account that Functions Like a Term Deposit Account: Kiraz Account

Fibabanka adds value to customers’ lives by developing a range of advantageous products in the field of Retail Banking. As one of the most important products of the bank, Kiraz Account helps customers utilize their savings, while functioning as an overnight deposit product whereby they can perform all their banking transactions from a demand deposit account. Combining the liquidity benefits offered by a demand deposit account with the profits of a term deposit account, Kiraz Account enables customers to utilize funds without waiting for the deposit maturity.

As a term deposit product that expands the customer base and reach more customers, Kiraz Account stood out as one of the Bank’s most important products in 2018. By the end of 2018, the total Kiraz Account balance rised to TL 1.54 billion from TL 712 million as at 2017 year end, an increase of 116%. More than 60 thousand customers now take advantage of Kiraz Account.

Kiraz Account can be opened via all Fibabanka branches, as well as via Call Center, Internet Banking and Mobile Banking. Kiraz Account sales can also be performed via the Direct Sales team, in line with Fibabanka’s goal of optimizing operational efficiency.

## “Instant Loan” Service

Tapping into its “Instant Loan” product, Fibabanka creates rapid and streamlined financial solutions across retail stores, to meet the needs of customers with a wide array of products, particularly including technology products. Loans extended under this scope can be utilized in minutes via customers’ ID information and mobile phones. Starting to develop loans for the stores of business partners in the last quarter of 2017, Fibabanka extended loans worth over TL 1.2 billion to 400 thousand customers in 2018. Fibabanka tripled the number of its active customers, compared to the previous year, without any additional burden on the existing workforce (the number of active retail customers increased to 560 thousand from 182 thousand.)

Tapping into Instant Loan, Fibabanka not only offers the convenience of rapid access to what customers need, but also provides favorable repayment conditions. This product also offers business partners the opportunity to significantly expand their market share and improve sales strategies. Becoming one of the most preferred banks in the retail sector with the Instant Loan product, Fibabanka also enhanced its customer-focused approach.

## Bancassurance

Fibabanka offers insurance and pension products, focusing on customer satisfaction, through partnerships with prominent insurance companies operating in the life and non-life segments.

Fibabanka undertook major projects to boost commission earnings on insurance production in 2018. Growing its insurance revenue by 258% in 2018 on a YoY basis, the Bank generated revenue of TL 52 million in this field. With this growth, the share of bancassurance commission earnings in the total net fees and commissions rose to 25.3%, from 12.5% in 2017.

Contributors to this growth included the Instant Loan product offered to retail customers, as well as the launch of technology-driven products, and the restructuring of new business models in the non-life branch for corporate customers.

In the upcoming period, Fibabanka aims to enhance customer experience and satisfaction by offering insurance and pension products, among the non-interest income items, with innovative solutions, as well as efforts towards digital transformation projects, diversification of alternative sales channels, and the integration of products into all sales channels.

## PRIVATE BANKING

For the Private Banking segment, Fibabanka aims to maintain its successful strategy in terms of meeting customers' needs and expectations under varying market conditions in the upcoming periods as well, based on its customized and dedicated approach.

In 2018, Fibabanka Private Banking increased its assets under management by 39% and expanded its active customer base by 69%.

**Increase in Active Customers**

Propelled by the long-standing experience and know-how of Fiba Group in the banking sector, Fibabanka undertook major achievements in the Private Banking segment as well. The Bank offers customized alternatives in this segment, based on the customer's risk profile and ROI expectations. Focusing solely on 'real persons', Fibabanka Private Banking serves 3,000 customers via Dedicated Customer Representatives across a total of 13 branches, with 10 branches based in Istanbul and the others in Ankara and Izmir.

Base on a customized and dedicated approach to private banking, Fibabanka develops banking products and services according to the risk and ROI preferences of customers. In this segment, the Bank offers a wide range of products with the support of Fiba Portföy Yönetimi A.Ş. and Fibabanka Treasury Department. In addition to term deposit accounts, fixed income securities such as treasury bills, treasury notes and private sector bills/bonds, as well as variable income securities such as mutual funds, are

extended as customer portfolios are being created. Customers can trade derivative products across over-the-counter markets, while performing their transactions at competitive prices to monetize booms and busts among parities with intra-day FX and parity transactions.

In 2018, Fibabanka increased the asset size managed in the Private Banking segment by 39%, and the number of active customers rose by 69%. Adopting a sustainable growth strategy, Fibabanka Private Banking provides banking services that simplify customers' lives, administered by professional, experienced customer representatives, and driven by values such as mutual trust, long-term customer relations and custom privacy. For the Private Banking segment, Fibabanka aims to maintain its successful strategy in terms of meeting customers' needs and expectations under varying market conditions in the upcoming periods as well, based on its customized and dedicated banking approach.

## CUSTOMER EXPERIENCE MANAGEMENT AND COMMUNICATION ACTIVITIES

Fibabanka established the Customer Experience Department in year-end 2017 in order to offer an even more excellent customer experience.



### Call Center

The Fibabanka Call Center underwent a multi-dimensional transformation in 2018, concluding the year with a focus on efficiency and process improvement.

In parallel with a rapidly expanding customer base over the year, the number of calls also rose. In addition, the staff turnover rate was significantly low at Fibabanka's Call Center, compared to the sector overall. In accordance with its goal of elevating both employee and customer satisfaction, Fibabanka focuses on enhancing functional skills and enabling the use of technology in the management of its Call Center. Starting to offer all Retail Banking products in inbound and outbound channels, the Bank made it possible to perform most transactions via the Call Center, instantly and on the phone, without the need for a visit to any branches or for back office processing.

The Fibabanka Call Center began to utilize a CRM application to consolidate all customer communications and experience on a joint platform and use them in business processes. Additionally, it made major investments into its Call Center team, which grew in both number and expertise in 2018.

Shaping its activities based on its vision of becoming the "Most Loved Bank of Turkey" Fibabanka treats customer satisfaction as a core component for successful sustainable performance both financially and operationally. Therefore, the Bank established the Customer Experience Department at the end of 2017 to manage all business processes and services in line with a customer-focused approach; in 2018, it undertook vigorous efforts to offer increasingly better customer experience.

Focusing on providing an excellent end-to-end experience to customers, not just when they are first contacted, but throughout their entire banking journey, Fibabanka aims to create bespoke solutions through fostering a customer-focused corporate culture.


### Communication Activities

Throughout its digital transformation process in 2018, Fibabanka successfully continued to perform its activities by maximizing next-generation communication technologies across internal and external platforms. The Bank made new investments in terms of its brand and corporate identity to build a closer and more sincere communication with customers. Adopting the motto "Agile thinking, agile solutions" along with the stance of personal customer services, the Bank carried out a number of promotional activities for its products and services, particularly on digital channels. Fibabanka aims to enhance and maintain its communication efforts in 2019.

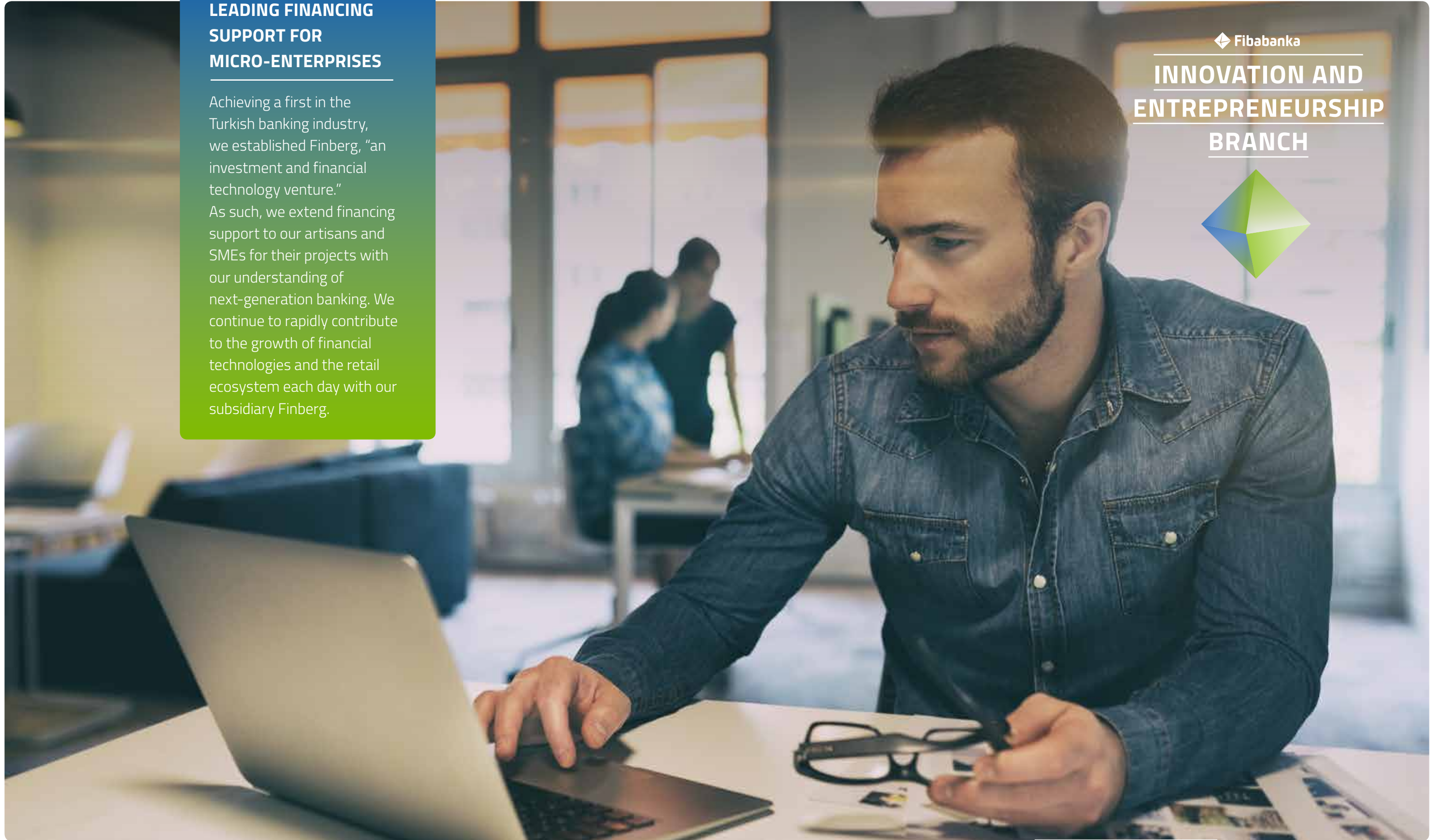


## LEADING FINANCING SUPPORT FOR MICRO-ENTERPRISES

DIGITAL TRANSFORMATION

With investments in digital transformation, Fibabanka increased the number of its active digital customers by 107.27% in 2018.

Fibabanka increased the number of active customers using Internet Banking by 74.44% compared to the previous year, with investments guided by the digital channel strategy.

Fibabanka manages its dedicated and ongoing digital transformation efforts in two stages. The Bank transforms points of contact with customers, while aiming to offer easy and quick access to products and services in line with changing needs. Moreover, it aims to launch designs that automate manual processes and implement infrastructure to realize this vision. Fibabanka considers emerging developments led by FinTechs in the banking sector as an opportunity, thus the Bank focuses on solutions that make a difference in its business model, via Finberg.

Agile Steps on the Journey to Digital Transformation

Driven by the Bank’s digital transformation goals, agile teams with a focus on projects and products were established in 2018, and operational processes gained momentum, due to this new working system.

Digital Channel Strategy

Tapping into the digital channel strategy, Fibabanka offers customers a rapid, lean, integrated, uninterrupted and personalized experience, data-driven and tested, via digital points of contact. Determining its strategic steps and priorities in 2018, the Bank initiated efforts to present Internet Banking and Mobile Banking channels to customers, featuring a new design and advanced functionality designed to offer the optimal digital customer experience. Furthermore, the Bank developed innovative products, such as Transfer on Duty, in collaborations with FinTechs.

Digital Transformation Performance of Fibabanka

ATM Improvements

Fibabanka took important steps to offer more rapid solutions to customers’ needs by renewing its ATM infrastructure in 2018.

As of the end of 2018, the Bank has a total of 82 ATMs, 14 of which are off-site and 68 of which are in the branches. Compared to the beginning of the year, the volume of transactions processed at Fibabanka ATMs grew by 27.3%, and the number of transactions by 21.7%. A total of 364,211 financial transactions were performed, and the total volume of transactions was TL 178,095,761.

R&D Efforts for New Services and Activities

Driven by the growth strategy built on digitalization and inclusion, Fibabanka established an R&D Center in 2018, in collaboration with Özyeğin University, to launch financial technologies. In 2018, Fibabanka offered a number of products and services to support projects such as improvement of digital processes, activation of non-branch channels, establishment of automated decision assistance structures, increasing automation, and restructuring of data-driven banking processes.

The Fibabanka R&D Center realized loan sales via the Call Center and Early Warning System as well as system enhancements for loan sales and scoring automation as part of the digitalization of loan processes. The Center developed projects for loan limits, collaterals and concentration management to increase the effectiveness of digital loan processes. The check concentration service was initially offered via Bizim Hesap, a Finberg investment.

Driven by a growth strategy built on digitalization and inclusion, Fibabanka established an R&D Center in 2018, in collaboration with Özyeğin University, to launch financial technologies.

Fibabanka R&D Center launched Transfer on Duty service that marked a first in the sector, enabling customers to transfer money between banks included in the system on 24/7 basis.

The Tablet App was deployed based on the Bank’s goal of offering quicker and easier banking services at locations where customers are based.

Also in 2018, various replacements were made by the R&D Center on the systems serving the business units. Integration efforts were initiated to manage and monitor treasury transactions from a single point in a more convenient and effective manner. The credit cards system and overdraft/loan trading account infrastructure were updated. Deposit pricing became more systematic, and systematic changes were made to ensure personalized pricing for customers. Improvements were made to facilitate batch payments for motor vehicles tax, which helped gain workforce and increase customer satisfaction.

With an aim to amplify labor productivity, the Fibabanka R&D Center launched the robot process automation project to minimize the operational burdens that increase with growth. The FibaNet communication platform, an application

that manages parametric business processes, was deployed to manage internal processes more effectively. Furthermore, the internal social network platform, FibaSocial, and corporate mobile application projects were completed to enhance communication among employees.

The Fibabanka R&D Center made an investment in a new, industry-standard data center within the scope of data security and infrastructure efforts. To this end, a new infrastructure was deployed, in a design complying with regulations, for integrated file spaces across documents, voice recordings and e-mail archives associated with customers. Investments into new hardware were performed as part of the data center renovation project. The conventional structure was transformed to a virtual system, with a hyper-converged infrastructure and utilization of future-ready technologies.

Firewalls were replaced by next-gen devices for network and application security; SIEM (i.e., correlation helping detect potential attacks by establishing meaningful connections between events that seem to be unrelated) adaptations were performed; and data loss, leakage protection and data classification tools were deployed.



FINANCIAL INSTITUTIONS

Fibabanka issued its first five-year Eurobond, amounting to USD 300 million, with an interest rate of 6%, in January 2018.

In its Financial Institutions department, Fibabanka focuses on expanding its correspondent network in parallel with the foreign trade demands of its customers. Additionally, it substantially contributes to the Bank’s funding needs by obtaining medium- and long-term financing by issuing eurobonds and subordinated bond instruments in international capital markets, as well as through bilateral loan agreements with international financial institutions.

International Capital Markets

Fibabanka issued its first five-year Eurobond, amounting to USD 300 million, with an interest rate of 6%, in January 2018. The Bank enjoyed long-term funding at favorable cost, thanks to this successful issuance completed at the beginning of 2018, with the expectation that borrowing costs would increase in 2018.

Foreign Funding and Loan Guarantee Facilities

The First and Only Turkish Bank to Participate in EaSI Program

In 2018, the Bank signed a loan guarantee agreement worth EUR 20 million with the European Investment Fund (EIF) as part of the EU Programme for Employment and Social Innovation (EaSI). Supported by the EU, the EaSI program particularly aims to support entrepreneurs and micro-enterprises willing to grow its business. As the first and only bank applying this program in Turkey, Fibabanka aims to extend loans to nearly 5,000 micro-enterprises.

Funds Borrowed from International Financial Institutions

Significant importance has been placed on its relations with the international financial institutions since Fibabanka joined Fiba Group. Loans borrowed from these institutions helped expand the Bank’s access to long-term loans and to diversify its funding sources. As of the end of 2018, Fibabanka has a long-term loan worth USD 125 million in total, utilized from five international financial institutions including IFC, DEG, FMO, EFSE and GGF. With these loans, the Bank aims to support the SME, agriculture, energy efficiency and renewable energy sectors.

Syndication

In December 2018, Fibabanka paid back its one-year term syndicated loan of EUR 94.6 million and USD 30 million.

Correspondent Banking

The Fibabanka Financial Institutions department expanded its Correspondent Banking network by developing relations with correspondent banks in the field of foreign trade transactions, funding and international payments. This is intended to fulfill in the optimal manner customers’ needs associated with foreign trade transactions.

Credit Exposure with Financial Institutions

In 2018, the Fibabanka Financial Institutions department continued to evaluate counterparty bank risks associated with domestic and international banks, and to establish treasury and commercial limits.

HUMAN RESOURCES

Fibabanka offers career development opportunities to employees in line with its “happy employees” approach, which is one of the fundamental principles of the Bank’s corporate vision.

Shaping its activities based on the vision of becoming the “Most Loved Bank of Turkey” Fibabanka treats employee satisfaction as a core factor behind sustainable and successful performance. Fibabanka’s human resources policy is based on the following principles:

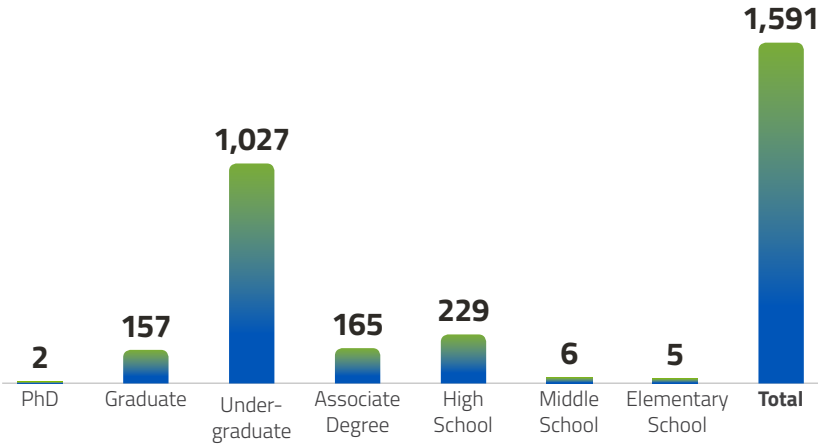

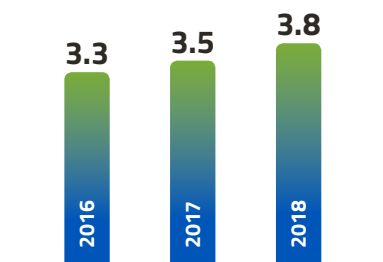

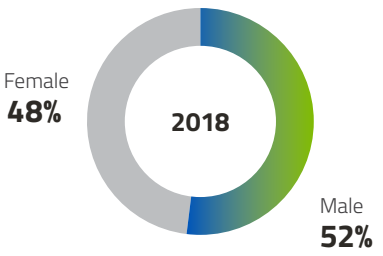

In 2018, it offered further professional training opportunities to employees on a regular basis, via the Operation Academy, the Sales Academy, the Financial Affairs Academy, the Law Academy, the Loans Academy, the Treasury Academy, the General Directorate Academy and IT Academy, all functioning under the Bank Academy. Moreover, numerous e-Learning channels were created for employees in line with current developments in educational technologies.

Offering continuous development opportunities for employees, Fibabanka scored 51 on the Employee Satisfaction Survey in 2018, six points higher than the previous year.

Born in 1944, Hüsnü M. Özyeğin obtained his undergraduate degree in Civil Engineering from Oregon State University and an MBA from Harvard Business School.

He served as General Manager and Board Member at Pamukbank T.A.Ş. from 1974 to 1984, and founded Finansbank A.Ş. in 1987, after serving as Deputy Chairman and General Manager of Yapı Kredi Bankası A.Ş. from 1984 to 1987. Hüsnü M. Özyeğin served as Chairman at Finansbank A.Ş. from the date of its establishment until 2010, and made numerous social investments with an exemplary social awareness.

The Bank recorded total assets of TL 20.6 billion as of December 31, 2018 on consolidated and solo bases. For the same period, on solo and consolidated bases, total equity amounted to TL 1.3 billion and paid-in capital stood at TL 941.2 million. Current year net profit was TL 197.0 million, according to consolidated financial statements, and TL 196.7 million according to solo financial statements.

He maintains his position as the Chairman of the Board of Trustees at the Hüsnü M. Özyeğin Foundation, which he founded in 1990, in addition to his roles as a Member of Board of Trustees at AÇEV, founded in 1993, and Chairman of the Board of Trustees at Özyeğin University, founded in 2007. Hüsnü M. Özyeğin is currently Chairman of the Board of Directors at Fiba Holding and Fibabanka A.Ş., and is also a Member of the Dean's Advisory Board at Harvard Business School.

### Fevzi BOZER

#### Deputy Chairman of the Board of Directors

Fevzi Bozer was born in 1955. Following his graduation from the Department of Business Administration at Indiana University, he completed his MBA at Roosevelt University. He served as General Manager at Finansbank Suisse (currently called Credit Europe Bank Suisse S.A.) in 1991-1993, and at Finansbank A.Ş.

## AUDIT COMMITTEE’S EVALUATIONS ON THE FUNCTIONING OF INTERNAL CONTROL, INTERNAL AUDIT AND RISK MANAGEMENT SYSTEMS, AND INFORMATION REGARDING THE ACTIVITIES DURING THE ACCOUNTING PERIOD

### 1- Risk Management Department

The main purpose of the Risk Management Department is to establish the methods, instruments and implementation procedures required to determine, measure, follow and control the risks carried by the Bank. Periodic assessment, measurement, reporting and control activities are conducted on a daily, weekly, monthly, quarterly and annual basis to this end. At the Assets and Liabilities Committee meetings, held once a week, and at the Risk Committee meetings, held once a month, an analysis of the details of trading portfolios, liquidity, market, interest rates and credit risks are made, and reporting activities are conducted accordingly. The Risk Management Department carries out its tasks based on a structure by which all Risk Management activities and calculations are performed using relevant systems and infrastructure.

The Department is composed of three units, including Market Risk, Capital Planning and Modeling, and Validation and Retail Loans Decision Support and Scoring. The units and their activities are summarized as follows:

**a. Market Risk Unit:** The aim is to manage the possible losses to which the Bank may be exposed due to general market risk, currency risk, specific risk, commodity risk and settlement risk, and the structural interest risk arising from banking accounts. At Assets and Liabilities Committee meetings, held once a week, and at Risk Committee meetings, held once a month, an analysis of the details of trading portfolios, liquidity, market, interest rates and credit risks are made, and reporting activities are conducted accordingly. Moreover, for transactions performed to manage the interest rate risk arising from banking accounts subjected to hedge accounting, analyses are carried out to identify the presence of the related hedge; its effectiveness is measured periodically; and regular analyses are performed to identify the presence of necessary circumstances for such a relation to be terminated.

**b. Capital Planning & Modeling and Validation Unit:** The aim is to manage the possible losses to which the Bank may be exposed due to the failure of credit customers to comply with the requirements of the concluded contract

and failure to fulfill the obligations partially or completely. In addition to IFRS 9 provision modeling, the tasks of the Unit include management and regular validation of the scoring models used in the corporate, commercial and SME segments of the Bank. The ICAAP (Internal Capital Adequacy Assessment Process) carried out annually, monthly reports pursuant to the “Regulation on Measurement and Assessment of Capital Adequacy of Banks” under Basel II, and all the risks borne by the Bank are tracked to the extent allowed by law and the Fibabanka Risk Appetite Policy approved by the Board of Directors. Applicable reports are presented and information regarding the risk profile of the Bank is provided to the Board on a monthly basis.

**c. Retail Loans Decision Support and Scoring Unit:** This Unit is intended to integrate credit policies in the Retail, Agricultural and Micro segments into the decision support system and independently manage the decision tree models. Furthermore, information regarding the Bank’s risk profile in this segment is provided by this Unit, with reports and analyses via implementation, allocation, follow-up and collections in the portfolio that fall under retail loans.

### 2- Internal Control and Operational Risk Department

For the operational risks to be managed more effectively under best practices and in integration with the Bank’s control systems, the Internal Control and Operational Risk Department is organized in two separate units, Internal Control and Operational Risk, and directly reports to the Audit Committee. The Internal Control and Operational Risk Department is comprised of 12 people.

The Internal Control Unit conducts its activities for the purposes of protecting the Bank’s assets; ensuring maintenance of the Bank’s activities in an efficient and productive manner in compliance with the Law and other related regulations, internal policies and rules of the Bank and general banking practices; and ensuring the reliability and integrity of accounting and financial reporting systems and having access to relevant information on time. The Internal Control Unit conducts auditing activities at the Head Office and at branches, and also performs the Management Declaration studies relating to banking processes.

The Operational Risk Unit is charged with determining operational risks defined as actual losses – incurred due to inadequate or failed internal processes, people and systems or from external events – differ, can differ, or may differ from projected losses, and their impacts, and managing them within the scope of the limits set by the Bank Risk Appetite Policy applied by the Bank, via methods such as prevention, mitigation and transfer. Furthermore, the activities of the Bank within the scope of Business Continuity Management and the “Regulation on Support Services Received by Banks” are conducted by this Unit.

### 3- Board of Inspection

Internal auditors holding ‘Certified Internal Auditor,’ ‘Certified Information Systems Auditor,’ ‘Certified Fraud Examiner,’ and ‘Independent Accountant and Financial Advisor’ certification are on the Fibabanka Inspection Board, comprising 13 members. The organizational layout of the Internal Audit Department is designed in to address Banking Processes and Information Technologies processes separately.

The Annual Internal Audit Program is prepared in parallel with the risk level determined as a result of risk assessment studies performed by the Internal Audit Department.

Within the scope of annual process and the Branch Audit Program of the Internal Audit Department, the Banking Process, COBIT Information Technologies Process within the scope of BRSA (Banking Regulation and Supervision Agency) Governance Statement, branch audits and other examinations are performed. Findings in these fields are submitted to the Audit Committee for assessment and evaluation.

### 4- Legislation and Compliance Department

The Legislation and Compliance Department has been established for the purposes of ensuring that all of the Bank’s current and planned activities, products and services are in compliance with related laws and regulations, and the Bank’s internal policies and procedures and banking practices; preventing Laundering of the Proceeds of Crime and Financing of Terrorism, and combating corruption. The Legislation and Compliance Department functions with 20 people, and reports to the Audit Committee.

It is also directly in charge of governing and monitoring the structure, processes and principles of the Corporate Governance of the Bank.



INFORMATION REGARDING THE RISK POLICIES IMPLEMENTED BY RISK TYPES

Market Risk Arising from Trading Portfolio

Various efforts are undertaken to ensure compliance with BRSA legislation in defining, measuring, reporting and tracking the market risk of the Bank; to minimize the losses that may be caused by the market risk of the Bank; and to improve the processes and standards.

The Bank may not maintain positions above the legal limit. Additionally, Value at Risk limits have been determined for the risk due to the trading portfolio maintained by the Bank within the scope of Trading Portfolio Policy. Compliance with these limits is tracked daily by the Risk Management Department.

Interest Rate Risk Arising from Banking Accounts

Pursuant to the Assets & Liabilities Policy, all components included in the assets and liabilities of the Bank are divided into maturity tranches based on remaining maturity periods by way of repricing, and predetermined interest shocks are applied to calculate the change in net

economic value. By the stress tests made on the interest risk maintained by the Bank through the Interest Risk Analysis, sensitivity of the risk level intended to be carried out is tested against crises scenarios and studies are performed to keep them under control.

Liquidity and Funding Risk

The Bank determines its policies for defining, measuring, reporting and controlling the liquidity risk according to international best practices and the rules and regulations set by the Banking Regulation and Supervision Agency.

When considering the liquidity position of the Bank; existing and expected assets quality, existing and future profitability capacity, funding needs based on previous experiences, existing liquidity position, and funding needs estimated to occur in the future, funding resources and cash flows are taken into account.

The organization, duties and responsibilities of the Bank’s Liquidity Risk Management have been defined in detail within the scope of the Liquidity and Funding Risk Policy and the basic principles, implementations, limits and reporting activities to be adopted for Liquidity Risk Management are specified. The short- and long-term liquidity risks carried by the Bank and the scenario analyses on the current positions of the Bank are presented to the Management via Liquidity Reports.

Credit Risk

The Bank has set model development and validation standards to anticipate, determine, measure, monitor, eliminate, mitigate and manage credit risk. These standards are developed for the purpose of correctly defining reliable credit clients with regards to credit policies.

TRANSACTIONS MADE WITH THE RISK GROUP IN WHICH THE BANK IS INVOLVED

Relevant reports are prepared, and controls are undertaken to determine, measure, report and control the credit risk. Loan provisions are calculated via an IFRS9-compliant model and based on the applicable legislation. Limits have been set for the Bank regarding the credit risk arising from transactions performed by the Treasury Department with other banks. Counter-party credit risk is also tracked via stress tests conducted monthly.

Concentration and risk limits developed for the Bank’s loan portfolio are reviewed through the Credit Risk Reports.

FINANCIAL STATUS, PROFITABILITY AND SOLVENCY ASSESSMENT

Fibabanka’s asset size increased by 3% to TL 20.6 billion as of end-2018 on solo and consolidated bases.

According to consolidated and unconsolidated financial statements, the volume of loans amounted to TL 14.1 billion as of end-2018, down from TL 15.1 billion in 2017. The share of loans in total assets was 68% in 2018.

Creditworthiness of loans and other receivables is monitored at certain intervals, in accordance with applicable legislation. For new loans, the Bank complies with the limits determined under the Banking Laws and Regulations. Collateral is taken for loans disbursed in order to reduce risk. According to consolidated and unconsolidated financial statements, non-performing loans as of end-2018 amounted to TL 622 million, for which a provision of TL 296 million was set aside.

The securities available for sale portfolio was TL 1.1 billion at year-end 2018, according to consolidated and unconsolidated financial statements. The ratio of securities to total assets was 6%.

The consolidated and unconsolidated deposit volume totaled TL 11.3 billion as of end-2018.

Profit before tax of TL 238.3 million was achieved according to consolidated financial statements in 2018. Following a tax provision of TL 41.3 million, net profit increased by 18% on a year-on-year basis, climbing to TL 197.0 million.

The Bank’s net interest income increased by 36% year-on-year to TL 872.5 million, while the total operating revenue saw growth of 64% and amounted to TL 945.4 million. The aforementioned figures are TL 873.4 million and TL 947.2 million, respectively, on a consolidated basis.

2018 operating expenses totaled TL 220.7 million and TL 222.0 million, on solo and consolidated bases respectively.

As of 31 December 2018, the Bank’s solo and consolidated capital adequacy ratio was 19.47%.

The Bank’s share capital is not unpaid and it suffers no insolvency.

There are no measures required to be taken to improve the financial structure of the Bank. The Bank continues to grow profitably according to its targets.

The profit distribution schedule of the Bank for 2018 is available in the Independent Auditor’s Report, in the section of unconsolidated financial statements. The decision relating to distribution of profit in 2018 shall be taken at the General Assembly meeting.

The currency risk, interest rate risk and liquidity risk borne by the Bank are measured and monitored with several risk management systems, and the balance sheets are managed accordingly, within the framework of predetermined risk limits and legal limits.

To protect against market risks, for purposes of financial risk management, the Bank has identified market risk

management activities and taken necessary measures under the “Regulation on Internal Systems and Internal Capital Adequacy Assessment Process of Banks” published in the Official Gazette dated 11 July 2014 no. 29057 and the “Regulation on Measurement and Assessment of Capital Adequacy of Banks” published in the Official Gazette dated 6 September 2014 no. 29111.

Market risk calculations are made monthly, and the obtained results of measurements are taken into account for the calculation of the Capital Adequacy Standard Ratio. As of 31 December 2018, the amount subject to market risk is TL 912 million.

The Standard Method and Value at Risk Method are used in measuring the exchange rate risk encountered by the Bank. Legal position limits are used for the purpose of limiting the encountered exchange rate risk. As of 31 December 2018, the Bank carried a long foreign currency position of TL 193 million.

Against the liquidity risk, attention is paid to ensure that consistency of maturity between assets and liabilities and liquid assets are maintained for the purpose of completely meeting the liquidity needs that may occur as a result of fluctuations in the market.

Efforts in this regard are supported through TL and FX cash flow projections, while changes in the maturity structure, cost and total amount of TL and FX deposits are tracked daily. Developments in previous periods and expectations regarding future developments are also taken into consideration as part of these efforts. Based on cash flow projections, measures are taken to meet liquidity needs by applying different pricing for various maturities. Furthermore, the amount of liquidity which may be needed in extraordinary situations is estimated, and alternative liquidity resources which may be used are determined.



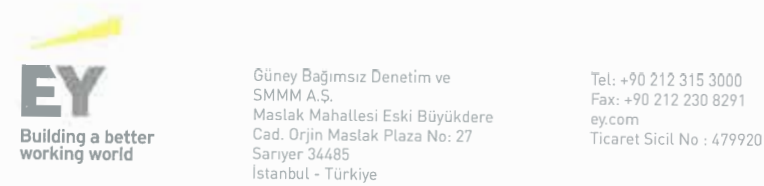

INDEPENDENT AUDITOR’S REPORT

To the General Assembly of Fibabanka Anonim Şirketi:

A) Report on the Audit of Unconsolidated Financial Statements

1) Qualified Opinion

We have audited the accompanying unconsolidated financial statements of Fibabanka Anonim Şirketi (the Bank), which comprise the statement of financial position as at December 31, 2018, and the unconsolidated statement of profit or loss accounted for under equity, unconsolidated statement of changes in equity and unconsolidated statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

In our opinion, except for the effect of the matter described in the “Basis for Qualified Opinion” section of our report, the accompanying unconsolidated financial statements present fairly, in all material respects, the unconsolidated financial position of Fibabanka A.Ş. as at December 31, 2018 and unconsolidated financial performance and unconsolidated its cash flows for the year then ended in accordance with the prevailing accounting principles and standards set out as in accordance with “Regulation on Accounting Applications for Banks and Safeguarding of Documents” published in the Official Gazette no.26333 dated 1 November 2006 and other regulations on accounting records of Banks published by Banking Regulation and Supervision Agency (BRSA), circulars, interpretations published by BRSA and “BRSA Accounting and Financial Reporting Legislation” which includes the provisions of Turkish Financial Reporting Standards (TFRS) for the matters which are not regulated by these regulations.

2) Basis for Qualified Opinion

As explained in detail in Note II-8 of Section 5, the accompanying unconsolidated financial statements as at December 31, 2018 include a general reserve which does not meet the relevant criterias in TAS 37 “Provisions, Contingent Liabilities and Contingent Assets” for possible risks provided by the Bank Management for possible results of the circumstances which may arise from possible changes in the economy and market conditions amounting to TL 65,000 thousands out of which TL 55,500 thousands and TL 9,500 thousands were provided during previous years and within the current period respectively with a current year deferred tax amounting to TL 14,300 thousands. As a result of accounting of aforementioned provision in financial statements, “Extraordinary Reserves” and “Current Period net Profit or Loss” are presented as TL 388,400 thousands and TL 196,659 thousands as of December 31, 2018, respectively.

Our audit was conducted in accordance with “Regulation on independent audit of the Banks” published in the Official Gazette no.29314 dated 2 April 2015 by BRSA (BRSA Independent Audit Regulation) and Independent Auditing Standards (“ISA”) which are the part of Turkish Auditing Standards issued by the Public Oversight Accounting and Auditing Standards Authority (“POA”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Bank in accordance with of Code of Ethics for Independent Auditors (Code of Ethics) published by POA and have fulfilled our other responsibilities in accordance with the code of ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

3) Key Audit Matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the unconsolidated financial statements of the current period. Key audit matters were addressed in the context of our audit of the unconsolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matters described in the Basis for Qualified Opinion section we have determined the matter described below to be the key audit matters to be communicated in our report.

#### 4) Responsibilities of Management and Directors for the Unconsolidated Financial Statements

Bank management is responsible for the preparation and fair presentation of the unconsolidated financial statements in accordance with the BRSA Accounting and Reporting Legislation and for such internal control as management determines is necessary to enable the preparation of the financial statement that is free from material misstatement, whether due to fraud or error.

In preparing the unconsolidated financial statements, management is responsible for assessing the Bank's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Bank or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Bank's financial reporting process.

#### 5) Auditor's Responsibilities for the Audit of the Unconsolidated Financial Statements

In an independent audit, the responsibilities of us as independent auditors are:

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with BRSA Independent Audit Regulation and ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with BRSA Independent Audit Regulation and ISAs, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the unconsolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. (The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.)
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Bank's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Bank's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the unconsolidated financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Bank to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the unconsolidated financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.



We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the directors with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the unconsolidated financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

#### B) Report on Other Legal and Regulatory Requirements

1) In accordance with Article 402 paragraph 4 of the Turkish Commercial Code ("TCC") no 6102; no significant matter has come to our attention that causes us to believe that the Bank's bookkeeping activities and financial statements for the period January 1 - December 31, 2018 are not in compliance with the laws and provisions of the Bank's articles of association in relation to financial reporting.

2) In accordance with Article 402 paragraph 4 of the TCC; the Board of Directors submitted to us the necessary explanations and provided required documents within the context of audit.

As explained in detail in Note 1 of Section 3, the effects of differences between accounting principles and standards set out by regulations in conformity with BRSA Accounting and Financial Reporting Legislation, accounting principles generally accepted in countries in which the accompanying unconsolidated financial statements are to be distributed and International Financial Reporting Standards ("IFRS") have not been quantified in the accompanying unconsolidated financial statements. Accordingly, the accompanying unconsolidated financial statements are not intended to present the financial position, results of operations and changes in financial position and cash flows in accordance with the accounting principles generally accepted in such countries and IFRS.

SECTION ONE  
GENERAL INFORMATION

I. History of the Bank Including Its Incorporation Date, Initial Status and Amendments to the Initial Status

On 21 December 2001, Share Transfer Agreement was signed with Novabank S.A. for the sale of all shares of Sitebank A.Ş. under the control of SDIF and the sale transaction was approved by the decision of Banking Regulation and Supervision Agency (“BRSA”) No: 596 on 16 January 2002.

In the General Assembly held on 4 March 2003, the name of Sitebank A.Ş. was amended as BankEuropa Bankası A.Ş.

In the extraordinary General Assembly held on 28 November 2006, the name of Bank Europa Bankası A.Ş. was amended as Millennium Bank A.Ş.

On 27 December 2010, acquisition of the Bank by Credit Europe Bank N.V., which is an affiliate of Fiba Holding A.Ş., was realized.

In the extraordinary General Assembly held on 25 April 2011 the name of Millennium Bank A.Ş. was amended as Fibabanka A.Ş. (“the Bank”).

II. Shareholder Structure, Shareholders Having Direct or Indirect, Joint or Individual Control Over the Management and Internal Audit of the Bank, Changes in Shareholder Structure During the Current Period, if any and Information on the Bank’s Risk Group

On 10 February 2010, Banco Comercial Portugues S.A. and Credit Europe Bank N.V., which is an affiliate of Fiba Group, signed a share purchase agreement to transfer 95% of the Bank’s shares to Credit Europe Bank N.V. and the legal approval process was completed as of 27 December 2010.

Credit Europe Bank N.V.’s share of capital increased from 95% to 97.6% after the capital increases during 2011 and 2012. Fiba Holding A.Ş. became the ultimate parent of the Bank after acquiring 97.6% of the shares from Credit Europe Bank N.V. on 3 December 2012 and 2.4% of the shares from Banco Comercial Portugues S.A. on 7 December 2012. There were sales of equity shares to the management of the Bank in 2013. As of December 31, 2018 the total shares held by the Bank’s Management represent 0.56% of the Bank’s Capital.

The Bank applied to the BRSA on 14 January 2015 for permission of the subordinated loan provided from Fiba Holding A.Ş. in the amount of USD 50 million to be converted to share capital. Following the authorization of the BRSA on 4 March 2015, the Board of Directors decision was taken on 5 March 2015 regarding share capital increase from TL 550,000 to TL 678,860. TL 127,045 of the increase was provided by the subordinated loan granted by Fiba Holding A.Ş. which had been approved to be converted to capital and TL 1,815 of total capital was paid in cash by the other shareholders, capital increase was recognised in financial satements following the completion of the legal procedures on 7 May 2015.

The Bank’s paid-in capital amounting to TL 678,860 was increased to TL 847,515 on 23 December 2015 with equal contributions from International Finance Corporation (“IFC”) and European Bank for Reconstruction and Development (“EBRD”) amounting TL 168,655 in total. In addition, share issuance premium of TL 73,379 was recognised in the shareholders’ equity.

SECTION THREE

ACCOUNTING PRINCIPLES

I. Explanations on the basis of presentation

1. Preparation of the financial statements and the accompanying footnotes in accordance with Turkish Accounting Standards and the Communiqué on Principles and Procedures on the Accounting Practice and Documentation of Banks

The Bank prepares its financial statements in accordance with the BRSA Accounting and Reporting Regulation which includes the regulation on “The Procedures and Principles Regarding Banks’ Accounting Practices and Maintaining Documents” published in the Official Gazette dated 1 November 2006 with No. 26333, and other regulations on accounting records of banks published by the Banking Regulation and Supervision Board and circulars and pronouncements published by the BRSA and Turkish Accounting Standards published by the Public Oversight Accounting and Auditing Standards Authority for the matters not regulated by the aforementioned legislations. The format and content of the publicly announced unconsolidated financial statements and notes to these statements have been prepared in accordance with the “Communique on Publicly Announced Financial Statements, Explanations and Notes to These Financial Statements” and “Communique on Disclosures About Risk Management to be Announced to Public by Banks” and amendments to this communique. The Bank keeps its books in Turkish Lira in accordance with the Banking Act, Turkish Commercial Code and Turkish Tax Legislation. The financial statements are prepared in thousands of TL based on the historical cost convention, except for the financial assets and liabilities carried at fair value.

Explanations about Leases Standard TFRS 16

“TFRS 16 Leases” standard came out on official gazette numbered 29826 on the date of 16 April 2018, to be implemented in accounting period after the date of 31 December 2018. According to this standard, difference between operational lease and financial lease disappeared so that all leasing transactions will be recognized as right-of-use assets and corresponding liability.

The standard will be effective from the periods beginning on or after 1 Jan, 2019 and the Bank’s adoption process regarding the mentioned amendments continues as of the reporting date. The Bank does not expect any significant impact on financials.

2. Accounting policies and valuation principles applied in preparation of financial statements

The accounting policies and valuation principles used in the preparation of the financial statements are selected and applied in accordance with the requirements set out in regulations, communiqués, statements and guidance published by the BRSA and if there is no special regulation by the BRSA, in accordance with the principles within TAS / TFRS. The accounting policies and valuation principles applied in the preparation of the accompanying financial statements are explained in Notes II and XXVI below.

In accordance with the transition rules of TFRS 9, the prior period financial statements and notes are not restated. Accounting policies and valuation principles used for the years 2018 and 2017 are presented separately in the notes.

II. Explanations on the usage strategy of financial instruments and on foreign currency transactions

1. Usage strategy of the financial instruments

The major factor in managing interest rate and liquidity risk at the balance sheet is parallel movement of assets and liabilities.

Exchange rate risk, interest rate risk and liquidity risk are controlled and measured by various risk management systems, and the balance sheet is managed under the limits set by these systems and the limits legally required. Value at risk models are used for this purpose.

Purchase-sale transactions of short and long-term financial instruments are realized within predetermined risk limits that are allowed for the purpose of increasing risk-free return on capital.

The foreign currency position is carried based on a currency basket to minimize the foreign exchange risk.

2. Foreign currency transactions

2.1 Foreign currency exchange rates used in converting transactions denominated in foreign currencies and their presentation in the financial statements

The Bank recognizes the foreign currency transactions in accordance with TAS 21 “The Effects of Changes in Foreign Exchange Rates”. Foreign exchange gains and losses arising from the foreign currency transactions are converted into Turkish Lira by using the exchange rates at the date of the transaction and recognized in accounting records. At the end of the periods, foreign currency assets and liabilities are converted into Turkish Lira by using the spot foreign currency exchange rates of the Bank at the end of the period and the related currency conversion differences are recognized as foreign exchange gains and losses.

As at the end of the related periods, the Bank’s foreign currency exchange rates are as follows:

2.2 Foreign exchange gains and losses included in the income statement

As of 31 December 2018, net foreign exchange profit included in the income statement is TL 73,200 (1 January - 31 December 2017: TL 21,055 loss ).

III. Explanations on Equity Investments

In the unconsolidated financial statements; subsidiaries and affiliates are accounted for in accordance with “TAS 27 - Separate Financial Statements”.

IV. Explanations on forward transactions, options and derivative instruments

The Bank’s derivative transactions mainly consist of currency swaps, interest rate swaps, currency options and currency forward purchase/sale contracts. The Bank does not have any embedded derivatives separated from the host contract.

The Bank’s derivative instruments held for trading are classified as “Derivative Financial Assets Measured at Fair Value through Profit and Loss” or “Derivative Financial Assets Measured at Fair Value through Other Comprehensive Income” in accordance with TFRS 9 and derivative instruments for hedging purpose are classified, measured and accounted in accordance with TAS 39 “Financial Instruments: Recognition and Measurement”, respectively.

The liabilities and receivables arising from the derivative transactions are recorded as off-balance sheet items at their contractual values.

Derivative transactions are measured at their fair values subsequent to their acquisition. In accordance with the classification of derivative financial instruments, if the fair value is positive, the amount is classified as "Derivative Financial Assets at Fair Value Through Profit or Loss" or "Derivative Financial Assets at Fair Value Through Other Comprehensive Income", if the fair value is negative, the amount is classified as "Derivative Financial Liabilities at Fair Value Through Profit or Loss" or "Derivative Financial Liabilities at Fair Value Through Other Comprehensive Income". The fair value differences of derivative financial instruments are recognized in the income statement under trading profit/loss line as profit/loss from derivative financial transactions.

Explanations on derivative financial instruments held for hedging

The Bank enters into cross currency interest rate swap transactions in order to hedge the change in fair values of fixed-rate financial instruments. While applying fair value hedge accounting, the changes in fair values of hedging instrument and hedged item are recognised in income statement.

If the hedging is effective, the changes in fair value of the hedged item, which is fixed rate TL denominated loans, are presented in statement of financial position together with the hedged item. Subsequently, derivative transactions are valued at their fair values and the changes in their fair values are recorded on balance sheet under “Derivative Financial Assets at Fair Value Through Profit or Loss” or “Derivative Financial Liabilities at Fair ValueThrough Profit or Loss”, respectively depending on the fair values being positive or negative. Fair value changes are recorded under income statement.

The Bank performs effectiveness test at the beginning of the hedge accounting period and at each reporting period.

The hedge accounting is discontinued when the hedging instrument expires, is exercised, sold or no longer effective. When discontinuing fair value hedge accounting, the cumulative fair value changes in carrying value of the hedged item arising from the hedged risk are amortized to income statement over the life of the hedged item from that date of the hedge accounting is discontinued.

V. Explanations on interest income and expenses

Interest income and expenses calculated using internal rate of return are recognized on accrual basis.

VI. Explanations on fee and commission income and expenses

Except for fees and commissions that are integral part of the effective interest rates of financial instruments measured at amortized costs, the fees and commissions are accounted for in accordance with “TFRS 15 Revenue from Contracts with Customers”. Except for certain fees related with certain banking transactions and recognized when the related service is given, fees and commissions received or paid, and other fees and commissions paid to financial institutions are accounted on accrual basis throughout the service period.

VII. Explanations on financial assets

Financial assets include cash on hand, contractual rights to receive cash or another financial asset from the counterparty or the right to exchange of financial instruments or equity instrument transactions of the counterparty. Financial assets are classified into three groups as financial assets at fair value through profit or loss, financial assets at fair value through other comprehensive income and financial assets measured at amortized cost.

1. Financial assets measured at fair value through profit or loss

Financial assets measured at fair value through profit or loss are financial assets other than the ones that are managed with business model that aims to hold to collect contractual cash flows or business model that aims to collect both the contractual cash flows and cash flows arising from the sale of the assets; and if the contractual terms of the financial asset do not lead to cash flows representing solely payments of principal and interest at certain date; that are either acquired for generating a profit from short term fluctuations in prices or are financial assets included in a portfolio aiming to short-term profit making. Financial assets measured at the fair value through profit or loss are initially recognized at fair value and remeasured at their fair value after recognition. All gains and losses arising from these valuations are reflected in the income statement.

Loans measured at fair value through profit or loss are subject to valuation in accordance with fair value principles and profit or losses, emerging as a result of valuation, are recognized under profit/loss accounts.

The Bank has classified a portion of its extended loans as financial assets measured at fair value through profit or loss, as per TFRS 9 standard. The aforementioned loans have been demonstrated on credits line under “Financial assets measured at fair value through profit or loss” on the balance sheet.

2. Financial assets measured at fair value through other comprehensive income

Financial assets are measured at fair value through other comprehensive income if financial asset is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on principal amount outstanding.

Financial assets measured at fair value through other comprehensive income are recognized by adding transaction costs to acquisition cost reflecting the fair value of the financial asset. After the recognition, financial assets measured at fair value through other comprehensive income are remeasured at fair value. Interest income calculated with effective interest rate method arising from financial assets at fair value through other comprehensive income and dividend income from equity securities are recorded to income statement. “Unrealized gains and losses” arising from the difference between the amortized cost and the fair value of financial assets measured at fair value through other comprehensive income are not reflected in the income statement of the period until the acquisition of the asset, sale of the asset, the disposal of the asset, and impairment of the asset and they are accounted under the “Accumulated other comprehensive income or expense to be reclassified through profit or loss” under shareholders’ equity. When these securities are collected or disposed of, the accumulated fair value differences reflected in the equity are recognized in the income statement.

Equity securities, which are classified as financial assets measured at fair value through other comprehensive income, that have a quoted market price in an active market and whose fair values can be reliably measured are carried at fair value. Equity securities that do not have a quoted market price in an active market and whose fair values cannot be reliably measured are carried at cost, less provision for impairment.

3. Financial assets measured at amortized cost

Financial assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are classified as financial assets measured at amortized cost.

Financial assets measured at amortized cost are initially recognized at acquisition cost including the transaction costs which reflect the fair value of those instruments and subsequently recognized at amortized cost by using effective interest rate method. Interest income obtained from financial assets measured at amortized cost is accounted in income statement.

The Bank has classified financial assets at fair value through other comprehensive income amounting to TL 153,266 which were previously classified as available-for-sale financial assets, “Financial assets measured at amortized cost” as of January 2018.

VIII. Explanations on expected credit loss

The Bank recognizes expected credit loss allowance for financial assets measured at amortized cost and measured at fair value through other comprehensive income.

As of 1 January 2018, the Bank recognizes provisions for impairment in accordance with TFRS 9 requirements according to the “Regulation on the Procedures and Principles for Classification of Loans by Banks and Provisions to be set aside” published in the Official Gazette dated 22 June 2016 numbered 29750. In this framework, as of 31 December 2017, method of provisioning for impairment as set out in accordance with the related legislation of BRSA has been changed by applying the expected credit loss model under TFRS 9. The expected credit loss estimates are required to be unbiased, probability-weighted and include supportable information about past events, current conditions, and forecasts of future economic conditions.

These financial assets are divided into three categories depending on the gradual increase in credit risk observed since their initial recognition:

Stage 1

For the financial assets at initial recognition or that do not have a significant increase in credit risk since initial recognition. Impairment for credit risk will be recorded in the amount of 12-month expected credit losses.

Stage 2

In the event of a significant increase in credit risk since initial recognition, the financial asset will be transferred to Stage 2. Impairment for credit risk will be determined on the basis of the instrument’s lifetime expected credit losses.

Stage 3

Stage 3 includes financial assets that have objective evidence of impairment at the reporting date. For these assets, lifetime expected credit losses are recognized.

As part of TFRS 9, expected credit loss models are improved in process of exposure at default, probability of default and loss given default. These models are formed by taking into consideration internal ratings systems, past data and prospective expectations and considering below factors;

- Costumer type (individual, corporate, commercial and SME)
- Product type
- Ratings used as part of internal ratings systems
- Collaterals
- Collection period
- Exposure at default
- Time passed from loan disbursement
- Time to maturity

**Exposure at Default:** Expresses the exposure amount when debtor defaults. It accounts along with the maturity of the borrower.

The amount of additional risk that may occur in case of default is added to the amount of risk and included in the calculations by using the credit conversion rates (CCR) for irrevocable commitments.

**Probability of Default:** Refers to the probability of default due to the inability of the debtor to fulfill its obligations. 12-month or lifetime estimation is performed according to whether there is an increase in credit risk or not.

**Loss Given Default:** In the default of the borrower, it is calculated as the expected credit loss to exposure at default. Loss given default models include inputs such as product type, customer segment, collateral structure, customer payment performance.

**Makroeconomic Factors:** Macroeconomic indicators are taken into account in determining the probability of default component in the expected credit loss calculation. Future macroeconomic forecasts are reflected in the expected credit loss calculations using more than one scenario.

While macroeconomic information is included, models and estimates reflecting the relationships between model risk parameters and macroeconomic variables are taken into consideration. The main macroeconomic indicators that make up these estimation models are the Gross Domestic Product (GDP) and the unemployment rate. Macroeconomic estimation models include more than one scenario and the related scenarios are taken into account in the expected credit loss calculations.

XIV. Explanations on leasing transactions

Duration of financial leasing contracts is maximum 4 years. Tangible assets obtained via financial leasing are classified as the Bank’s assets or liabilities resulting from financial leasing according to its nature. Assets obtained via financial leasing are depreciated in accordance with the principals for tangible assets. Rent payments for operating leases are recorded at equal amounts as expense during the payment period.

XV. Explanations on provisions and contingent liabilities

Provisions and contingent liabilities are accounted in accordance with TAS 37 “Provisions, Contingent Liabilities and Contingent Assets”. In the financial statements, a provision is made if there is a present obligation that arises from past events as of the balance sheet date, if it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and if a reliable estimate can be made of the amount of the obligation. If the amount is not reliably estimated and there is no probability of cash outflow from the Bank to settle the liability, the related liability is considered as “contingent” and disclosed in the notes to the financial statements.

Provisions recognized during the period are recognized within “other operating expenses”; reversals of provisions recognized in the prior periods are recognized within “other operating income”.

XVI. Explanations on contingent assets

The contingent assets usually arise from unplanned or other unexpected events that give rise to the possibility of an inflow of economic benefits to the Bank. If an inflow of economic benefits has become probable, then the contingent asset is disclosed in the notes to the financial statements. If it has become virtually certain that an inflow of economic benefits will arise, the asset and the related income are recognized in the financial statements of the period in which the change occurs.

XVII. Explanations on liabilities for employee benefits

As per the existing labour laws and agreements in Turkey, entities are required to pay severance for the employees retired or fired. These payments are qualified as recognized retirement benefit plan according to revised TAS 19 Employee Benefits. Severance payment liability recognized in the balance sheet is calculated according to the net present value of expected amount in the future arising from all employees’ retirements and represented in financial statements. All actuarial losses and gains are accounted for as other comprehensive income.

The major assumptions used in the actuarial calculation are as follows:

- a. Calculation is based on discount rate of 13.50%, inflation rate of 6.00% and real rate of rise in salary of 0.00%.
- b. Effective as of 31 December 2018, ceiling salary amount is considered as TL 5,434.42 (full TL).
- c. Individuals’ earliest retirement age is considered as retirement age.
- d. CSO 1980 mortality table is used for the death probabilities of male and female employees.

There is no employee foundation, fund or similar institutions.

XVIII. Explanations on taxation

1. Current Tax

Effective from 1 January 2006, statutory income is subject to corporate tax at 20%, on the other hand as per the provisional article 91 of Law numbered 7061, which is added to Corporate Tax Law numbered 5520 corporate tax rate regarding 2018, 2019 and 2020 fiscal periods (accounting periods starting within the related period for companies which are assigned special accounting period) has changed as 22%. This rate is applied to accounting income modified for certain exemptions (like dividend income) and deductions (like investment incentives), and additions for certain non-tax deductible expenses and allowances for tax purposes.

If there is no dividend distribution planned, no further tax charges are made. Dividends paid to the resident institutions and the institutions working through local offices or representatives are not subject to withholding tax. As per the decisions no.2009/14593 and no.2009/14594 of the Council of Ministers published in the Official Gazette no.27130 dated 3 February 2009, certain duty rates included in the articles no.15 and 30 of the new Corporate Tax Law no.5520 are revised. Accordingly, the withholding tax rate on the dividend payments other than the ones paid to the non-resident institutions generating income in Turkey through their operations or permanent representatives and the resident institutions is 15%. In applying the withholding tax rates on dividend payments to the non-resident institutions and the individuals, the withholding tax rates covered in the related Double Tax Treaty Agreements are taken into account. Appropriation of the retained earnings to capital is not considered as profit distribution and therefore is not subject to withholding tax.

The prepaid taxes are calculated and paid at the rates valid for the earnings of the related years. The prepayments can be deducted from the annual corporate tax calculated for the whole year earnings.

In accordance with the tax legislation, tax losses can be carried forward to offset against future taxable income for up to five years. Tax losses cannot be carried back to offset profits from previous periods.

In Turkey, there is no procedure for a final and definite agreement on tax assessments. Companies file their tax returns with their tax offices by the end of 25th of the fourth month following the close of the accounting period to which they relate. Tax returns are open for five years from the beginning of the year that follows the date of filing during which time the tax authorities have the right to audit tax returns, and the related accounting records on which they are based, and may issue re-assessments based on their findings.

2. Deferred Tax

The Bank calculates and recognizes deferred tax for taxable temporary differences arising between the carrying values of assets and liabilities in the financial statements and their corresponding balances considered in the calculation of the tax base according to the Turkish Accounting Standard 12 (TAS 12) “Income Taxes”.

In accordance with the provisional article, added to Corporate Tax Law, corporate tax, which is 20% for the year 2017, shall be applied as 22% for the profit of company belonging to 2018, 2019 and 2020 fiscal periods. In accordance with this provisional article, 22% tax rate has been calculated for periods, in which the deferred tax assets and liabilities emerges and liabilities are met, while it is calculated with 20% for 2021 and following periods.

Deferred tax liabilities are generally recognized for all taxable temporary differences and deferred tax assets are recognized for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilized. Deferred tax asset was not computed over general loan loss and free provisions according to the circular of BRSA numbered BRSA.DZM.2/13/1-a-3 and dated 8 December 2004.

On the other hand deferred tax calculation has started to be applied over all temporary expected credit losses as per TFRS 9 articles from 1 January 2018. The Bank calculates deferred tax for the possible risk provisions, as well.

As of 31 December 2018, the deferred tax asset is TL 79,305 (31 December 2017: TL 9,472 the deferred tax asset). The deferred tax asset is calculated as the net of taxable and deductible temporary differences.

2. Deferred Tax (continued)

Deferred tax income/(expense) is recognized within “Deferred Tax expense effect” in the income statement; deferred tax expense for the current period is TL 41,161 (1 January - 31 December 2017: TL 12,777 income). Deferred tax effects of the transactions and events recognized directly in the shareholders’ equity are also recognized directly in the shareholders’ equity which is TL 4,262 income (1 January -31 December 2017: TL 1,931 expense).

3. Transfer pricing

The article 13 of the Corporate Tax Law describes the issue of transfer pricing under the title of “disguised profit distribution” by way of transfer pricing. “The General Communiqué on Disguised Profit Distribution by Way of Transfer Pricing” published at 18 November 2007, explains the application related issues on this topic.

According to this Communiqué, if the taxpayers conduct transactions like purchase and sale of goods or services with the related parties where the prices are not determined according to the arm’s length principle, then it will be concluded that there is a disguised profit distribution by way of transfer pricing. Such disguised profit distributions will not be deducted from the corporate tax base for tax purposes.

As stated in the “7.1 Annual Documentation” section of this communiqué, the taxpayers are required to fill out the “Transfer Pricing, Controlled Foreign Entities and Thin Capitalization” form for the purchase and sale of goods or services conducted with their related parties in a taxation period, attach these forms to their corporate tax returns and submit to the tax offices. Related forms are submitted to tax offices on time.

XIX. Additional explanations on borrowings

The Bank provides resources from domestic and foreign individuals and institutions both by borrowing funds and issuing bills and bonds.

Borrowing instruments are initially measured at acquisition cost and subsequently measured at amortized cost with the effective interest method. In the accompanying financial statements, foreign currency denominated borrowing funds are converted into Turkish Lira with the Bank’s spot foreign exchange buy rates and interest expenses incurred during the period relating to the borrowing funds are recognized in income statement.

XX. Explanations on share certificates issued

None.

XXI. Explanations on bank acceptances and bills of guarantee

Bank acceptances and bills of guarantee are presented within off-balance sheet liabilities as being possible liabilities and commitments. Cash transactions relating to bank acceptances and bills of guarantee are realized concurrently with the customer payments.

As of the balance sheet date, there are no bank acceptances and bills of guarantee recognized as liability against an asset.

XXII. Explanation on government incentives

As of the balance sheet date, the Bank does not have any government incentives.

**Explanations on Credit Risk :**

Credit risk is defined as risks and losses that may occur if the counterparty fails to comply with the agreement’s requirements and cannot perform its obligations partially or completely on the terms set.

The debtors or group of debtors are subject to credit risk limits. The debtors’ or group of debtors’ and industrial risk limitations are monitored weekly. Industry concentration is followed monthly.

Credit risk limits and breakdowns for daily transactions are followed daily. Risk concentrations of off-balance sheet risks are followed by remote and on-site control activities.

Credit worthiness of both commercial loans’ and all other debtors are being regularly monitored in accordance with the regulations. By utilizing risk rating models which were developed for these purposes, in case the debtors’ risk level increases, credit lines are readjusted and additional collaterals are received if needed. The necessary documentation for utilized loans is taken in compliance with the related legislation.

In accordance with the Bank’s lending policies, the debtor’s creditworthiness is analysed and the adequate collateral is obtained based on the financial position of the company and the type of loan; such as cash collateral, bank guarantees, mortgages, pledges, bills and corporate guarantees.

There are control limits based on VaR over the positions of the Bank which are held as futures, option contracts and other similar contracts. The credit risks carried for such instruments are managed together with the risks arising from market fluctuations.

Indemnified non-cash loans are subject to the same risk weight with overdue loans.

The Bank performs foreign trade finance and other interbank credit transactions through widespread correspondent network. Accordingly, the Bank assigns limits periodically to domestic banks, foreign banks and other financial institutions based on review of their credit worthiness.

Within the Bank’s risk appetite policy, the following concentrations are measured. They are presented to the Asset and Liability Committee weekly and to the Risk Committee monthly.

As per Customer Group Concentration, Top 20 corporate debtor’s / risk group’s credit risk sum shall not exceed 35% of the Bank’s total credit risk.

Within the industry concentration, the Bank has set its risk appetite as “reasonable”, not to exceed 10% of total loans per sector except the industries listed below.

Industry	Proportional Limit
Construction	20%
Tourism	10%
Factoring	15%
Wholesale and Retail Business	15%

Within the framework of risk appetite policy, the sum of long-term loans which have a maturity more than 1 year, shall not exceed 45% of the bank’s total loans. This ratio is monitored on a weekly basis at the Asset and Liability Committee and on a monthly basis at the Risk Committee.

The Bank’s largest 100 and 200 cash loan customers compose 55% and 65% of the total cash loan portfolio, respectively (31 December 2017: 49% and 57%, respectively).

The Bank’s largest 100 and 200 non-cash loan customers compose 78% and 89% of the total non-cash loan portfolio, respectively (31 December 2017: 75% and 85%, respectively).

The Bank’s largest 100 and 200 cash and non-cash loan customers represent 53% and 64% of the total “on and off balance sheet” assets, respectively (31 December 2017: 46% and 56%, respectively).

Expected credit loss for total credit risk amounts to TL 288,131(Stage 1 and Stage 2) (31 December 2017: TL 70,580).

Position limit on currency risk is determined in line with net general position standard ratio on foreign currency. The Bank does not take material foreign exchange and parity risk; transactions are usually hedged. Measurable and manageable risks are taken within legal limits.

As of 31 December 2018, the Bank's net long position is TL 193,034 (31 December 2017: TL 92,480 net short position) resulting from short position on the balance sheet amounting to TL 2,327,903 (31 December 2017: TL 1,050,041 short position) and long position on the off-balance amounting to TL 2,520,937 (31 December 2017: TL 957,561 long position). The Bank uses “Standard Method” in legal reporting to measure the foreign exchange risk.

## IV. Explanations on interest rate risk

Interest sensitivity of assets, liabilities and off-balance sheet items are evaluated weekly by considering market developments in the Asset-Liability Committee.

Standard method and Asset-Liability risk measurement methods are used to measure the Bank’s interest rate risk.

Measurements by employing the standard method are carried out monthly by using maturity ladder. Bank applies interest rate shock analysis to interest rate sensitive assets and liabilities considering historic economic crisis. Change in the net present value of the net assets of the Bank are monitored within the limits set by the Board of Directors.

**VI. Explanations on liquidity risk and liquidity coverage ratio**

The Board of Directors reviews the liquidity and funding risk management policy weekly or in case of necessity. Liquidity risk is managed by Asset and Liability Committee (ALCO) in line with risk management policy as short and long term liquidity risk.

Liquidity Risk is managed by ALCO in order to take the necessary measures in a timely and correct manner against possible liquidity shortages. Treasury department manages cash inflows and outflows in line with strategies determined by ALCO. As deemed necessary by the ALCO members, liquidity meetings are performed for the purposes of close monitoring. Treasury department manages short term liquidity by adhering to the ALCO strategy and ensuring compliance with legal liquidity limits and stress testing.

In the context of TL and foreign currencies liquidity management, the Bank monitors the cash flows weekly and action plan is made based on ALCO decisions. The funding balance is directly monitored and compensated by making the risk-return-cost evaluation.

For long-term liquidity "Maturity Mismatch Report" is prepared and presented to ALCO on a weekly basis. The Bank, resulting from the general structure of Turkish banking sector, has a liquidity gap at the 7 month maturity period. The Bank intends to eliminate liquidity mismatch shifting focus to long-term funding alternatives. Such decisions of the risk of incompatibility are taken by ALCO. The Bank diversifies its funding sources among customer deposits, domestic and foreign borrowings, bills and bonds issued, taking into consideration the maturity match between its assets and liabilities and keeps liquid assets in order to fully meet the liquidity requirements that may emerge in case of market volatility.

**Information on the use of stress testing**

Department of Risk Management implements stress testing according to Liquidity and Funding Risk Policy approved by the Board of Directors on a weekly basis. These stress tests are based on the scenarios of the deposit outflow, funds obtained from bonds issued will outflow, banks limits will not be used during a 14-day period, the results are included in the presentation of ALCO on a weekly basis and in the Presentation of Risk Committee on a monthly basis. By this way, the Bank’s funding structure is closely monitored and actions are taken on behalf of existing risk management.

Alternative funding sources are identified in case of need. ALCO members are responsible for taking actions against short-term liquidity shocks. In the case of a crisis or if deemed necessary, ALCO summon a meeting and take necessary actions immediately. These action plans are approved by the Board of Directors under the İSEDES. The Bank reviews resources that are available in any emergency situation constantly and takes into consideration the results of the above-mentioned stress testing and scenario analysis by the early warning system.

According to BRSA’s “Legislation on Measurement and Assessment of Liquidity Adequacy of the Banks”; published in the Official Gazette numbered 28948, dated 21 March 2014; liquidity ratio is required to be 70% for foreign currency assets/liabilities and 90% for total assets/liabilities in the calculation of the banks’ weekly and monthly reporting effective from 1 January 2018.

The Bank implements the calculation in accordance with the Regulation of Liquidity Coverage Ratio Calculation of Banks dated 21 March 2014 and numbered 28948 published in the Official Gazette. As per the related regulation high quality liquid assets are mainly securities portfolio, cash assets and reserve requirements. The important factors affecting the results of the liquidity coverage ratio are the changes in the remaining maturities of the items and changes in the amounts of deposits and money market transactions, the remaining maturities of which are less than 30 days. Deposits form a significant portion of the Bank's sources of funds, on the other hand bonds issued, money market borrowings, funds provided from abroad are other important sources of funding.

The bank calculates the cash outflow and collaterals due to derivative transactions based on the 24-month averages in accordance with the regulation on the liquidity ratio calculation of banks published in the official gazette No. 28948 dated 21 March 2014. In accordance with the Banking Regulation and Supervision Agency's decision no 7940 dated 07/09/2018, guarantees received for derivative transactions are not included in the calculation of liquidity adequacy ratio, effective from 31 July 2018 until 31 December 2018.

X. Explanations on securitisations positions

The Bank does not have any securitization positions as of balance sheet date.

XI. Explanations on risk management objectives and policies

The Bank does not apply any netting on balance sheet and off-balance sheet. Guarantees and derivatives are not used as credit mitigation techniques; but only financial collaterals consisting of cash blockages are used.

Risk Management System refers to the Board of Directors, the Audit Committee, the Risk Management Committee, the Asset-Liability Committee and the Risk Management Department which have been composed in order to manage systemic risks that the Bank is exposed to. The Board of Directors is the owner of the Bank's Risk Management System and ensures the establishment of an effective, sufficient and appropriate risk management system as well as the continuity of the system. The main objective of the Bank's Risk Management System is to identify, measure, monitor and control the risks that the Bank is exposed to, by determining the policies, limits and procedures to control, to monitor, and if necessary to change the risk-return structure of the Bank's future cash flows, the level and the quality of related activities.

As part of the Risk Management System, the Asset and Liability Committee presentation is prepared on a weekly basis and the Risk Committee and the Board of Directors presentations are prepared on a monthly basis. The presentations mainly consist of the Bank's financial statements, profit and loss analysis, credit risk, market risk, liquidity risk, concentration risk, interest rate risk due to banking book, and operational risk as well as the risk that the Bank is currently exposed to or possible risks.

The Board of Directors of the Bank delegated the authorization related to the hedge accounting to The Asset and Liability Committee with the condition of providing regular information. At the same time the Bank has organized credit policies and risk mitigation policies due to credit risk. All processes of the Bank are controlled by the Bank's Internal Control Department's control matrices regularly and are subject to supervision by the Internal Audit Department at the same time.

The Bank uses credit rating models and/or decision trees and rating systems using financial and non-financial data for loan customers as a risk measurement system. Market risk measures are calculated within the scope of the Regulation on Measurement and Evaluation of Capital Adequacy of Banks and using only internal model and market data for intra-bank use. In addition to these, risks are measured and reported with regular stress tests. Three stress tests (base, negative, extremely negative) are performed on a yearly basis, stress tests are performed on a monthly basis for market risk and counter party credit risk, stress tests are performed on a weekly basis for interest rate risk and liquidity risk by Risk Management Department of Bank and then they are shared with senior management in the ALCO and the Risk Committee meetings.

Periodic reports about liquidity risk, interest risk, securities portfolio, credit risk, customer concentration, sectoral concentration, collateral structure and capital adequacy are reported to the Board of Directors and senior management.

Explanation on the differences between the risk amounts and the amounts assessed in accordance with TAS in the financial statements:

Disclosures regarding differences between amounts valued according to TAS and risk exposures

The differences between the amounts assessed under TAS and the amounts after risk reduction in transactions subject to counterparty credit risk stem from the addition of potential risk amounts to the renewal costs of derivative transactions subject to the CPR and the volatility adjustments for repo / reverse repo transactions. Funds provided to differences arising from risk reduction are also included by opening separate line for them.

Valuations of securities subject to market risk in accordance with TAS represent the fair value of held for trading financial instruments. On the other hand, the values in the risk amount line represents the amount subject to market risk based on the capital requirements calculated for the losses arising due factors such as interest rate risk of the market risk, equity price risk, currency risk in accordance with the “Regulation for Measurement and Evaluation of Banks’ Capital Adequacy Ratio”.

If financial instruments that are accounted for at their fair value are traded in an active market, the valuation is based on that market price. The TL borrowing instruments in the held for trading securities portfolio comprise of government securities. These securities are evaluated at the weighted average trading price in the Istanbul Stock Exchange. For TL securities that are not traded, the market price is calculated based on the CBRT prices. For the FX securities in the same portfolio, the average of purchase and sale quotations in the market are considered as the market price. Derivative financial instruments are evaluated using the discounted cash flow model using market data. Input data used in evaluations using market value and/or valuation methods are periodically checked for validity and independence.

Information on Credit Risk

General Qualitative Information on Credit Risk:

The Bank’s credit risk management policies are established in line with the strategy approved by the Board of Directors in accordance with the related regulations and are based on prudence, sustainability and the customers’ credit worthiness principles.

The limits are set in accordance with the Risk Policies by the Board of Directors based on the Bank’s risk appetite. In accordance with the determined risk limits, the authorizations and sub-authorizations are done by the Credit Policies which is in line with the determined limits. Special attention is given to ensure that the limits are in line with market expectations and the Bank’s strategies.

Credit rating models and decision trees are used in the credit underwriting processes in accordance with the risk appetite, credit policies set by the Bank and the targets of the Bank. The grading of all customers except for individual credit customers by the Bank is essential. The individual loan portfolio is managed via an automated decision trees.

Customer selection is carried out in accordance with policies and strategies of the Bank and is based on the ability to pay on time and the cash flows expected to be received from its operations independent from guarantees, sureties and pledged assets. When needed; it is mandatory for the Bank to obtain appropriate collateral in line with the source of the payment for the repayment of the credit from the customers to ensure that their obligations arising from the credit are met on time and in full. The main purpose of collateralization of any loan is to minimize the credit, foreign exchange and maturity risks. In this context, a minimum collateral margin is determined by taking into account the collateral quality and the collection expectations given default and it is ensured that the appropriate collateral is obtained based on the credit type. Before a credit relationship is established with a customer, an analysis and intelligence collection are carried out in order to measure the creditworthiness of the customers. Before the credit decisions; the customer is examined and evaluated with an analysis for factors that have affected its past, present and future performances and any other factors (financial and non-financial data) that may affect its past, present and future performances.

General Qualitative Information on Credit Risk (continued):

Credit risk is encountered when the counterparty is unable to fulfill its obligations defined with the agreement. All credit risk bearing banking products are managed with prudent credit policies and procedures in the Bank. The credit quality of the counterparty is evaluated with an internal rating score in all corporate, commercial and SME credit transactions. In order to monitor the credit risk, internal limits are determined on the basis of sector, maturity, customer and internal rating to avoid the risk of concentration.

Credit risk management is a process in which credit risks are assessed and monitored in a consistent manner, besides all credit portfolios are included on a consolidated basis. Credit risk is managed on the basis of portfolios, risk / return balance and asset quality of the Bank, and the credit risk is governed by the principles contained in the policy documents. In addition, credit-based evaluation, underwriting and follow-up are carried out by the units in the Loans group within the framework of the relevant processes. Loans proposals are evaluated by the credit units of the Headquarters, if necessary, within the framework of the level of authority based on the determined amount and finalized the loan proposal by the Credit Committee and the Board of Directors.

The units carry out their risk management activities in accordance with the risk appetite and capacity of the Bank through the use of risk measurement and management tools within the policies established by the Board of Directors. In this context, the organizational structure for credit risk management and control functions is detailed as follows the units included in the scope of Credit Risk Management are Corporate Loans, Commercial and SME Loans Allocation, Credit Monitoring and Collection Department and Risk Analysis Department. Decisions on credit policies are taken by the Credit Committee.

Allocated credit limits and usages, exceeded limits, assessments of large risks and overdue loans are regularly reported to the senior management.

In the course of credit risk management, the Risk Management Department conducts monitoring and reporting of internal concentration limits. It is ensured that the policies related to the concentration risk management are prepared and processed within the policies of allocation, monitoring, limit monitoring and management. Regular reporting on the cost of the loan and the development of the following loans is made. In addition, stress test and scenario analysis studies related to the loan portfolio are carried out within the scope of ICAAP.

The evaluation of the internal systems established to cover all branches and units and the maintenance of the continuity of functioning, competence and efficiency are among the highest priorities of the Bank's Board of Directors. Within the scope of internal systems, the duties and responsibilities of the Board of Directors, Internal Audit, Internal Control and Operational Risk and Risk Management activities are carried out by the Audit Committee.

Information on credit risk mitigation techniques

The Bank does not apply any netting on balance sheet and off-balance sheet. Guarantees and derivatives are not used as credit mitigation technique; only financial collaterals consisting of cash blockages are used.

Applications related to the valuation and management of collaterals are defined as follows: Appraisals for the mortgages that are received as collaterals are only performed by the firms that have been approved by the BRSA and licensed by the Capital Markets Board (“CMB”). Appraisal reports for the real estates that are received as collaterals for commercial loans, are renewed each year as long as the risk continues. As a rule, each year a different appraisal firm is preferred. Management of the appraisal process is carried out by the Appraisal & Real Estate Project Finance Unit. Vehicle pledges are followed through their insurance values. Regular investigations are performed for the cheques and bills that are received as collaterals and in case of any negative finding the Bank seeks to replace the collateral.

The Bank’s collaterals are mainly composed of cheques, notes, mortgages, guarantees, vehicle pledges and deposit pledges. The Bank’s credit risk concentration mainly consists of corporate receivables and are followed by receivables that are collateralized with mortgage, SME and retail receivables, respectively.

Explanations on market risk

Whether the bank within the financial risk management objectives hedges itself against market risk, the precautions taken by the Board of Directors for market risk, the methods used for measuring market risk and time intervals for measurement of market risk

In order to hedge against the market risk within the context of the risk management objectives, the Bank sets its activities related with market risk management in accordance with “Regulations on Banks’ Internal Control and Risk Management Systems” published in the Official Gazette no. 29057 dated 11 July 2014 and “Regulation on Measurement and Assessment of Capital Adequacy Ratios of Banks” published in the Official Gazette no. 29511 dated 23 October 2015.

Being exposed to market risk, Bank’s Board of Directors have defined risk management strategies and policies about risk managements in line with application and recommendation of group and have led to follow-up strategies periodically. The limits of risks are identified and these limits are revised periodically. Board of Directors ensures that risk management group and executive managers should identify, measure, control and manage the Bank’s risk.

Market risk arising from trading transactions is limited through the risk appetite policy approved by Board of Directors as “low” and measured by taking into consideration BRSA’s standart methodology. Additionally Financial Control Department reports the market value and realized profit/loss of trading portfolio.The Risk Management and Asset Liability Committee continuously monitor compliance of trading transactions with the risk appetite policy. Market risk caused by mismatches of asset-liability maturities is also monitored through GAP reports.

Stress tests and scenario analysis are also applied in order to reflect the effects of prospective severe market fluctuations in the VaR calculations. Risk measurement methods such as cash flow projections and GAP analysis are also applied.

Capital to be kept for general market risk and specific risk are calculated by using a standard method in accordance with “Measurement and Assessment of Bank Capital Adequacy Regulation” and are reported monthly.

To the General Assembly of Fibabanka Anonim Şirketi:

A) Report on the Audit of Consolidated Financial Statements

1) Qualified Opinion

We have audited the accompanying consolidated financial statements of Fibabanka A.Ş (the Bank) and its subsidiary (together will be referred as the “Group”), which comprise the statement of financial position as at December 31, 2018, and the consolidated statement of profit or loss accounted for under equity, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

In our opinion, except for the effect of the matter described in the “Basis for Qualified Opinion” section of our report, the accompanying consolidated financial statements present fairly, in all material respects, the consolidated financial position of Fibabanka A.Ş. as at December 31, 2018 and consolidated financial performance and consolidated its cash flows for the year then ended in accordance with the prevailing accounting principles and standards set out as in accordance with “Regulation on Accounting Applications for Banks and Safeguarding of Documents” published in the Official Gazette no.26333 dated 1 November 2006 and other regulations on accounting records of Banks published by Banking Regulation and Supervision Agency (BRSA), circulars, interpretations published by BRSA and “BRSA Accounting and Financial Reporting Legislation” which includes the provisions of Turkish Financial Reporting Standards (TFRS) for the matters which are not regulated by these regulations.

2) Basis for Qualified Opinion

As explained in detail in Note II-8 of Section 5, the accompanying consolidated financial statements as at December 31, 2018 include a general reserve which does not meet the relevant criterias in TAS 37 “Provisions, Contingent Liabilities and Contingent Assets” for possible risks provided by the Bank Management for possible results of the circumstances which may arise from possible changes in the economy and market conditions amounting to TL 65,000 thousands out of which TL 55,500 thousands and TL 9,500 thousands were provided during previous years and within the current period respectively with a current year deferred tax amounting to TL 14,300 thousands. As a result of accounting of aforementioned provision in financial statements, “Extraordinary Reserves” and “Current Period net Profit or Loss” are presented as TL 388,400 thousands and TL 197,014 thousands as of December 31, 2018, respectively.

Our audit was conducted in accordance with “Regulation on independent audit of the Banks” published in the Official Gazette no.29314 dated 2 April 2015 by BRSA (BRSA Independent Audit Regulation) and Independent Auditing Standards (“ISA”) which are the part of Turkish Auditing Standards issued by the Public Oversight Accounting and Auditing Standards Authority (“POA”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Bank in accordance with of Code of Ethics for Independent Auditors (Code of Ethics) published by POA and have fulfilled our other responsibilities in accordance with the code of ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

3) Key Audit Matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. Key audit matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matters described in the Basis for Qualified Opinion section we have determined the matter described below to be the key audit matters to be communicated in our report.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Bank to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the Group to express an opinion on the consolidated financial statements. We are responsible for the direction, supervision and performance of the Group audit. We remain solely responsible for our audit opinion.



We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the directors with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the consolidated financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

#### B) Report on Other Legal and Regulatory Requirements

- 1) In accordance with Article 402 paragraph 4 of the Turkish Commercial Code ("TCC") no 6102; no significant matter has come to our attention that causes us to believe that the Bank's bookkeeping activities and financial statements for the period January 1 - December 31, 2018 are not in compliance with the laws and provisions of the Bank's articles of association in relation to financial reporting.
- 2) In accordance with Article 402 paragraph 4 of the TCC; the Board of Directors submitted to us the necessary explanations and provided required documents within the context of audit.

#### Additional paragraph for convenience translation to English

As explained in detail in Note 1 of Section 3, the effects of differences between accounting principles and standards set out by regulations in conformity with BRSA Accounting and Financial Reporting Legislation, accounting principles generally accepted in countries in which the accompanying consolidated financial statements are to be distributed and International Financial Reporting Standards ("IFRS") have not been quantified in the accompanying consolidated financial statements. Accordingly, the accompanying consolidated financial statements are not intended to present the financial position, results of operations and changes in financial position and cash flows in accordance with the accounting principles generally accepted in such countries and IFRS.

SECTION ONE  
GENERAL INFORMATION

I. History of the Parent Bank including its incorporation date, initial status and amendments to the initial status

On 21 December 2001, Share Transfer Agreement was signed with Novabank S.A. for the sale of all shares of Sitebank A.Ş. under the control of SDIF and the sale transaction was approved by the decision of Banking Regulation and Supervision Agency (“BRSA”) No: 596 on 16 January 2002.

In the General Assembly held on 4 March 2003, the name of Sitebank A.Ş. was amended as BankEuropa Bankası A.Ş.

In the extraordinary General Assembly held on 28 November 2006, the name of Bank Europa Bankası A.Ş. was amended as Millennium Bank A.Ş.

On 27 December 2010, acquisition of the Bank by Credit Europe Bank N.V., which is an affiliate of Fiba Holding A.Ş., was realized.

In the extraordinary General Assembly held on 25 April 2011 the name of Millennium Bank A.Ş. was amended as Fibabanka A.Ş. (“the Bank” or “the Parent Bank”).

II. Shareholder structure, shareholders having direct or indirect, joint or individual control over the management and internal audit of the Parent Bank, changes in shareholder structure during the current period, if any and information on the Parent Bank’s risk group

On 10 February 2010, Banco Comercial Portugues S.A. and Credit Europe Bank N.V., which is an affiliate of Fiba Group, signed a share purchase agreement to transfer 95% of the Bank’s shares to Credit Europe Bank N.V. and the legal approval process was completed as of 27 December 2010.

Credit Europe Bank N.V.’s share of capital increased from 95% to 97.6% after the capital increases during 2011 and 2012. Fiba Holding A.Ş. became the ultimate parent of the Bank after acquiring 97.6% of the shares from Credit Europe Bank N.V. on 3 December 2012 and 2.4% of the shares from Banco Comercial Portugues S.A. on 7 December 2012. There were sales of equity shares to the management of the Bank in 2013. As of December 31, 2018 the total shares held by the Bank’s Management represent 0.56% of the Bank’s Capital.

The Parent Bank, applied to the BRSA on 14 January 2015 for permission of the subordinated loan provided from Fiba Holding A.Ş. in the amount of USD 50 million to be converted to share capital. Following the authorization of the BRSA on 4 March 2015, the Board of Directors decision was taken on 5 March 2015 regarding share capital increase from TL 550,000 to TL 678,860. TL 127,045 of the increase was provided by the subordinated loan granted by Fiba Holding A.Ş. which had been approved to be converted to capital and TL 1,815 of total capital was paid in cash by the other shareholders, capital increase was recognised in financial satements following the completion of the legal procedures on 7 May 2015.

The Parent Bank’s paid-in capital amounting to TL 678,860 was increased to TL 847,515 on 23 December 2015 with equal contributions from International Finance Corporation (“IFC”) and European Bank for Reconstruction and Development (“EBRD”) amounting TL 168,655 in total. In addition, share issuance premium of TL 73,379 was recognised in the shareholders’ equity.

SECTION THREE

ACCOUNTING PRINCIPLES

- I. Explanations on the basis of presentation
1. Preparation of the financial statements and the accompanying footnotes in accordance with Turkish Accounting Standards and the Communiqué on Principles and Procedures on the Accounting Practice and Documentation of Banks

The Bank and its consolidated financial subsidiaries prepare their consolidated financial statements in accordance with the BRSA Accounting and Reporting Regulation which includes the regulation on “The Procedures and Principles Regarding Banks’ Accounting Practices and Maintaining Documents” published in the Official Gazette dated 1 November 2006 with No. 26333, and other regulations on accounting records of banks published by the Banking Regulation and Supervision Board and circulars and pronouncements published by the BRSA and Turkish Accounting Standards published by the Public Oversight Accounting and Auditing Standards Authority for the matters not regulated by the aforementioned legislations. The format and content of the publicly announced consolidated financial statements and notes to these statements have been prepared in accordance with the “Communique on Publicly Announced Financial Statements, Explanations and Notes to These Financial Statements” and “Communique on Disclosures About Risk Management to be Announced to Public by Banks” and amendments to this communiqué. The Bank keeps its books in Turkish Lira in accordance with the Banking Act, Turkish Commercial Code and Turkish Tax Legislation.

The consolidated financial statements are prepared in thousands of TL based on the historical cost convention, except for the financial assets and liabilities carried at fair value.

Explanations about Leases Standard TFRS 16

“TFRS 16 Leases” standard came out on official gazette numbered 29826 on the date of 16 April 2018, to be implemented in accounting period after the date of 31 December 2018. According to this standard, difference between operational lease and financial lease disappeared so that all leasing transactions will be recognized as right-of-use assets and corresponding liability.

The standard will be effective from the periods beginning on or after 1 Jan, 2019 and the Bank’s adoption process regarding the mentioned amendments continues as of the reporting date. The Bank does not expect any significant impact on financials.

2. Accounting policies and valuation principles applied in preparation of consolidated financial statements

The accounting policies and valuation principles used in the preparation of the financial statements are selected and applied in accordance with the requirements set out in regulations, communiqués, statements and guidance published by the BRSA and if there is no special regulation by the BRSA, in accordance with the principles within TAS / TFRS. The accounting policies and valuation principles applied in the preparation of the accompanying financial statements are explained in Notes II and XXVI below.

In accordance with the transition rules of TFRS 9, the prior period financial statements and notes are not restated. Accounting policies and valuation principles used for the years 2018 and 2017 are presented separately in the notes.

- II. Explanations on the usage strategy of financial instruments and on foreign currency transactions

1. Usage strategy of the financial instruments

The major factor in managing interest rate and liquidity risk at the balance sheet is parallel movement of assets and liabilities.

Exchange rate risk, interest rate risk and liquidity risk are controlled and measured by various risk management systems, and the balance sheet is managed under the limits set by these systems and the limits legally required. Value at risk models are used for this purpose.

Purchase-sale transactions of short and long-term financial instruments are realized within predetermined risk limits that are allowed for the purpose of increasing risk-free return on capital.

The foreign currency position is carried based on a currency basket to minimize the foreign exchange risk.

2. Foreign currency transactions

2.1 Foreign currency exchange rates used in converting transactions denominated in foreign currencies and their presentation in the financial statements

The Group recognizes the foreign currency transactions in accordance with TAS 21 “The Effects of Changes in Foreign Exchange Rates”. Foreign exchange gains and losses arising from the foreign currency transactions are converted into Turkish Lira by using the exchange rates at the date of the transaction and recognized in accounting records. At the end of the periods, foreign currency assets and liabilities are converted into Turkish Lira by using the spot foreign currency exchange rates of the Bank and the related currency conversion differences are recognized as foreign exchange gains and losses.

As at the end of the related periods, the Bank’s foreign currency exchange rates are as follows:

2.2 Foreign exchange gains and losses included in the income statement

As of 31 December 2018, net foreign exchange profit included in the income statement is TL 73,200 (1 January - 31 December 2017: TL 21,055 loss ).

III. Explanations on consolidated subsidiaries

Fiba Portföy Yönetimi A.Ş. (“Fiba Portföy”); the subsidiary of the Bank was consolidated by using full consolidation method in the consolidated financial statements dated 31 December 2018. Fibabanka A.Ş. and Fiba Portföy Yönetimi A.Ş. together are referred to as “the Group” in the report.

Capital Markets Board (“CMB”) approved Fiba Portföy’s licence application for portfolio management activity and the licence numbered PYŞ. PY 56/1267 and dated 12 December 2013 was assigned to Fiba Portföy.

The objective of Fiba Portföy is to manage portfolios consisting of financial assets as a representative by entering into portfolio management contracts in accordance with CMB laws and relevant regulation and also to perform capital markets operations. Besides, Fiba Portföy can manage the portfolios of local and foreign investment funds, investment trusts, local/foreign real persons, brokerage companies and other similar legal entities within the context of the related regulation as portfolio management activities.

On the condition that, the requirements of the Capital Markets regulations are fulfilled and necessary approvals and licences from the Capital Markets Board are obtained; Fiba Portföy can also perform investment advisory services, market consultancy in Borsa İstanbul A.Ş. Emerging Companies Market, and intermediary services for the trading of investment fund certificates. The Bank owns 99% of the equity of Fiba Portföy whose headquarters is located in İstanbul.

According to full consolidation method, the subsidiary’s 100% of assets, liabilities, revenues, expenditures and off-balance sheet liabilities were combined with the Parent Bank’s assets, liabilities, revenues, expenditures and off-balance sheet liabilities. Book value of the investment in the Group’s subsidiary and the portion of the cost of subsidiary’s capital belonging to the Group are eliminated. All intragroup balances and income and expenses relating to transactions between the Bank and its subsidiary are eliminated in full on consolidation. Minority shares in the net income of consolidated subsidiary determined the net income of the Group and were demonstrated as a separate item in the income statement. Minority shares were presented under equity in the consolidated financial statement.

IV. Explanations on forward transactions, options and derivative instruments

The Parent Bank’s derivative transactions mainly consist of currency swaps, interest rate swaps, currency options and currency forward purchase/sale contracts. The Parent Bank does not have any embedded derivatives separated from the host contract.

The Parent Bank’s derivative instruments held for trading are classified as “Derivative Financial Assets Measured at Fair Value through Profit and Loss” or “Derivative Financial Assets Measured at Fair Value through Other Comprehensive Income” in accordance with TFRS 9 and derivative instruments for hedging purpose are classified, measured and accounted in accordance with TAS 39 “Financial Instruments: Recognition and Measurement”, respectively.

IV. Explanations on forward transactions, options and derivative instruments (continued)

The liabilities and receivables arising from the derivative transactions are recorded as off-balance sheet items at their contractual values. Derivative transactions are measured at their fair values subsequent to their acquisition. In accordance with the classification of derivative financial instruments, if the fair value is positive, the amount is classified as "Derivative Financial Assets at Fair Value Through Profit or Loss" or "Derivative Financial Assets at Fair Value Through Other Comprehensive Income", if the fair value is negative, the amount is classified as "Derivative Financial Liabilities at Fair Value Through Profit or Loss" or "Derivative Financial Liabilities at Fair Value Through Other Comprehensive Income". The fair value differences of derivative financial instruments are recognized in the income statement under trading profit/loss line as profit/loss from derivative financial transactions.

Explanations on derivative financial instruments held for hedging

The Parent Bank enters into cross currency interest rate swap transactions in order to hedge the change in fair values of fixed-rate financial instruments. While applying fair value hedge accounting, the changes in fair values of hedging instrument and hedged item are recognised in income statement.

If the hedging is effective, the changes in fair value of the hedged item, which is fixed rate TL denominated loans, are presented in statement of financial position together with the hedged item. Subsequently, derivative transactions are valued at their fair values and the changes in their fair values are recorded on balance sheet under “Derivative Financial Assets at Fair Value Through Profit or Loss” or “Derivative Financial Liabilities at Fair Value Through Profit or Loss”, respectively depending on the fair values being positive or negative. Fair value changes are recorded under income statement.

The Parent Bank performs effectiveness test at the beginning of the hedge accounting period and at each reporting period.

The hedge accounting is discontinued when the hedging instrument expires, is exercised, sold or no longer effective. When discontinuing fair value hedge accounting, the cumulative fair value changes in carrying value of the hedged item arising from the hedged risk are amortized to income statement over the life of the hedged item from that date of the hedge accounting is discontinued.

V. Explanations on interest income and expenses

Interest income and expenses calculated using internal rate of return are recognized on accrual basis.

VI. Explanations on fee and commission income and expenses

Except for fees and commissions that are integral part of the effective interest rates of financial instruments measured at amortized costs, the fees and commissions are accounted for in accordance with “TFRS 15 Revenue from Contracts with Customers”. Except for certain fees related with certain banking transactions and recognized when the related service is given, fees and commissions received or paid, and other fees and commissions paid to financial institutions are accounted on accrual basis throughout the service period.

VII. Explanations on financial assets

Financial assets include cash on hand, contractual rights to receive cash or another financial asset from the counterparty or the right to exchange of financial instruments or equity instrument transactions of the counterparty. Financial assets are classified into three groups as financial assets at fair value through profit or loss, financial assets at fair value through other comprehensive income and financial assets measured at amortized cost.

1. Financial assets measured at fair value through profit or loss

Financial assets measured at fair value through profit or loss are financial assets other than the ones that are managed with business model that aims to hold to collect contractual cash flows or business model that aims to collect both the contractual cash flows and cash flows arising from the sale of the assets; and if the contractual terms of the financial asset do not lead to cash flows representing solely payments of principal and interest at certain date; that are either acquired for generating a profit from short term fluctuations in prices or are financial assets included in a portfolio aiming to short-term profit making. Financial assets measured at the fair value through profit or loss are initially recognized at fair value and remeasured at their fair values after recognition. All gains and losses arising from these valuations are reflected in the income statement.

Loans measured at fair value through profit or loss are subject to valuation in accordance with fair value principles and profit or losses, emerging as a result of valuation, are recognized under profit/loss accounts.

The Bank has classified a portion of its extended loans as financial assets measured at fair value through profit or loss, as per TFRS 9 standard. The aforementioned loans have been demonstrated on credits line under “Financial assets measured at fair value through profit or loss” on the balance sheet.

2. Financial assets measured at fair value through other comprehensive income

Financial assets are measured at fair value through other comprehensive income if financial asset is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on principal amount outstanding.

Financial assets measured at fair value through other comprehensive income are recognized by adding transaction costs to acquisition cost reflecting the fair value of the financial asset. After the recognition, financial assets at fair value through other comprehensive income are remeasured at fair value. Interest income calculated with effective interest rate method arising from financial assets at fair value through other comprehensive income and dividend income from equity securities are recorded to income statement. “Unrealized gains and losses” arising from the difference between the amortized cost and the fair value of financial assets measured at fair value through other comprehensive income are not reflected in the income statement of the period until the acquisition of the asset, sale of the asset, the disposal of the asset, and impairment of the asset and they are accounted under the “Accumulated other comprehensive income or loss to be reclassified through profit or loss” under shareholders’ equity. When these securities are collected or disposed of, the accumulated fair value differences reflected in the equity are recognized in the income statement.

Equity securities, which are classified as financial assets measured at fair value through other comprehensive income, that have a quoted market price in an active market and whose fair values can be reliably measured are carried at fair value. Equity securities that do not have a quoted market price in an active market and whose fair values cannot be reliably measured are carried at cost, less provision for impairment.

3. Financial assets measured at amortized cost

Financial assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are classified as financial assets measured at amortized cost.

Financial assets measured at amortized cost are initially recognized at acquisition cost including the transaction costs which reflect the fair value of those instruments and subsequently recognized at amortized cost by using effective interest rate method. Interest income obtained from financial assets measured at amortized cost is accounted in income statement.

The Bank has classified financial assets at fair value through other comprehensive income amounting to TL 153,266 which were previously classified as available-for-sale financial assets to “Financial assets measured at amortized cost” as of January 2018.

VIII. Explanations on expected credit loss

The Parent Bank recognizes expected credit loss allowance for financial assets measured at amortized cost and measured at fair value through other comprehensive income.

As of 1 January 2018, the Bank recognizes provisions for impairment in accordance with TFRS 9 requirements according to the “Regulation on the Procedures and Principles for Classification of Loans by Banks and Provisions to be set aside” published in the Official Gazette dated 22 September 2016 numbered 29750. In this framework, as of 31 December 2017, method of provisioning for impairment as set out in accordance with the related legislation of BRSA has been changed by applying the expected credit loss model under TFRS 9. The expected credit loss estimates are required to be unbiased, probability-weighted and include supportable information about past events, current conditions, and forecasts of future economic conditions.

These financial assets are divided into three categories depending on the gradual increase in credit risk observed since their initial recognition:

Stage 1

For the financial assets at initial recognition or that do not have a significant increase in credit risk since initial recognition. Impairment for credit risk will be recorded in the amount of 12-month expected credit losses.

Stage 2

In the event of a significant increase in credit risk since initial recognition, the financial asset will be transferred to Stage 2. Impairment for credit risk will be determined on the basis of the instrument’s lifetime expected credit losses.

Stage 3

Stage 3 includes financial assets that have objective evidence of impairment at the reporting date. For these assets, lifetime expected credit losses are recognized.

As part of TFRS 9, expected credit loss models are improved in process of exposure at default, probability of default and loss given default. These models are formed by taking into consideration internal ratings systems, past data and prospective expectations and considering below factors;

- Costumer type (individual, corporate, commercial and SME)
- Product type
- Ratings used as part of internal ratings systems
- Collaterals
- Collection period
- Exposure at default
- Time passed from loan disbursement
- Time to maturity

**Exposure at Default:** Expresses the exposure amount when debtor defaults. It accounts along with the maturity of the borrower.

The amount of additional risk that may occur in case of default is added to the amount of risk and included in the calculations by using the credit conversion rates (CCR) for irrevocable commitments.

**Probability of Default:** Refers to the probability of default due to the inability of the debtor to fulfill its obligations. 12-month or lifetime estimation is performed according to whether there is an increase in credit risk or not.

**Loss Given Default:** In the default of the borrower, it is calculated as the expected credit loss to exposure at default. Loss given default models include inputs such as product type, customer segment, collateral structure, customer payment performance.

**Macroeconomic Factors:** Macroeconomic indicators are taken into account in determining the probability of default component in the expected credit loss calculation. Future macroeconomic forecasts are reflected in the expected credit loss calculations using more than one scenario.

While macroeconomic information is included, models and estimates reflecting the relationships between model risk parameters and macroeconomic variables are taken into consideration. The main macroeconomic indicators that make up these estimation models are the Gross Domestic Product (GDP) and the unemployment rate.

Macroeconomic estimation models include more than one scenario and the related scenarios are taken into account in the expected credit loss calculations.

Future expectations are determined based on 2 scenarios, base and negative. Each scenario has predetermined weights, and the final provisions are calculated by weighting on these probabilities.

**Calculation of Expected Loss Period:** In determining the lifetime expected credit loss, the period in which the Bank will be exposed to credit risk is taken into consideration. Behavioral maturity analysis was performed on credit cards and overdraft accounts. The maximum period for which credit losses are to be recognized, except for credit cards and other rotative loans, is the contractual life of the financial instrument unless a legal right is required to recall the loan.

**Significant Increase in Credit Risk:** Due to the significant increase in credit risk, the Bank performs quantitative and qualitative assessments to determine the financial assets to be classified as Stage 2 (Significant Increase in Credit Risk).

Within the scope of the quantitative assesments made for the corporate segment, the Bank compares the change between the starting date and the date of the report by taking into account the time passed since the opening date. In order to make this comparison, the Bank specifies threshold values to determine which changes are accepted as significant change. The decision to classify financial assets as Stage 2 due to a significant increase in credit risk by exceeding these threshold values is taken by the opinion of the Credit Department.

Within the scope of qualitative evaluations, financial assets included in the scope of close monitoring as of the reporting date are classified as Stage 2.

IX. Explanations on offsetting financial instruments

Financial assets and liabilities are offset and the net amount is reported in the balance sheet when the Group has a legally enforceable right to offset the recognized amounts and there is an intention to collect/pay the related financial assets and liabilities on a net basis, or to realize the asset and settle the liability simultaneously.

X. Explanations on sale and repurchase agreements and securities lending transactions

Securities subject to repo (repurchase agreements) are classified as “Financial assets at fair value through profit or loss”, “Financial assets at fair value through other comprehensive income” or “Financial assets measured at amortized cost” according to their purposes to be held in the Bank’s portfolio and evaluated within the principles of the relevant portfolio. Funds obtained from repurchase agreements are followed under the “Funds from repo transactions” account in liabilities, and interest expense accruals are calculated using the effective interest (internal rate of return) method on the difference between the sales and repurchase prices corresponding to the period designated by a repurchase agreement. Securities purchased under agreements to resell (“Reverse repo”) transactions are accounted under the “Money market placements” in the balance sheet.

XI. Explanations on noncurrent assets held for sale and discontinued operations and the related liabilities

A tangible asset (or a disposal group) classified as “asset held for sale” is measured at the lower of the carrying value or fair value less costs to sell. Assets held for sale are not depreciated and presented in the financial statements separately. An asset (or a disposal group) is regarded as “asset held for sale” only when the sale is highly probable and the asset (or disposal group) is available for immediate sale in its present condition. For a highly probable sale, there must be a valid plan prepared by the management for the sale of asset including identification of possible buyers and completion of sale process. Furthermore, the asset should be actively marketed at a price consistent with its fair value.

Events or circumstances may extend the period to complete the sale beyond one year. An extension of the period required to complete a sale does not preclude an asset (or disposal group) from being classified as held for sale if the delay is caused by events or circumstances beyond the entity's control and there is sufficient evidence that the entity remains committed to its plan to sell the asset (or disposal group).

A discontinued operation is part of the Group’s business classified as disposed or held-for-sale. The operating results of the discontinued operations are disclosed separately in the income statement.

The Group does not have any discontinued operations.

XII. Explanations on goodwill and other intangible assets

As at the balance sheet date, there is no goodwill in the accompanying financial statements. The intangible assets of the Group consist of software, intangible rights and other intangible assets.

The costs of the intangible assets purchased before 1 January 2005 are recognized at their inflation adjusted costs as of 31 December 2004 and intangible assets purchased after 1 January 2005 are recognized at their acquisition cost less accumulated amortization and impairment, if any.

Estimated useful lives of the intangible assets are 3 to 10 years, and amortization rates are 10% to 33.3%.

If there is objective evidence of impairment, the asset’s recoverable amount is estimated in accordance with the Turkish Accounting Standard 36 (TAS 36) “Impairment of Assets” and if the recoverable amount is less than the carrying value of the related asset, an allowance for impairment is recognized.

XIII. Explanations on tangible assets

Tangible assets are measured at cost in accordance with the Turkish Accounting Standard 16 (TAS 16) “Tangible Assets”.

The costs of the tangible assets purchased before 1 January 2005 are recognized at their inflation adjusted costs as of 31 December 2004 and tangible assets purchased after 1 January 2005 are recognized at their acquisition cost less accumulated depreciation and impairment, if any.

If there is objective evidence of impairment, the asset's recoverable amount is estimated in accordance with the Turkish Accounting Standard 36 (TAS 36) "Impairment of Assets" and if the recoverable amount is less than the carrying value of the related asset, an allowance for impairment is recognized.

Gains/losses from the sale of the tangible assets are calculated as the difference between the net book value and the net sales price.

Maintenance and repair costs incurred for tangible assets are recorded as expense.

There are no restrictions such as pledges, mortgages or any other restriction on tangible assets.

There are no changes in the accounting estimates that are expected to have an impact in the current or subsequent periods.

XIV. Explanations on leasing transactions

Duration of financial leasing contracts is maximum 4 years. Tangible assets obtained via financial leasing are classified as the Bank’s assets or liabilities resulting from financial leasing according to its nature. Assets obtained via financial leasing are depreciated in accordance with the principals for tangible assets. Rent payments for operating leases are recorded at equal amounts as expense during the payment period.

XV. Explanations on provisions and contingent liabilities

Provisions and contingent liabilities are accounted in accordance with TAS 37 “Provisions, Contingent Liabilities and Contingent Assets”. In the financial statements, a provision is made if there is a present obligation that arises from past events as of the balance sheet date, if it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and if a reliable estimate can be made of the amount of the obligation. If the amount is not reliably estimated and there is no probability of cash outflow from the Bank to settle the liability, the related liability is considered as “contingent” and disclosed in the notes to the financial statements.

Provisions recognized during the period are recognized within “other operating expenses”; reversals of provisions recognized in the prior periods are recognized within “other operating income”.

XVI. Explanations on contingent assets

The contingent assets usually arise from unplanned or other unexpected events that give rise to the possibility of an inflow of economic benefits to the Group. If an inflow of economic benefits has become probable, then the contingent asset is disclosed in the notes to the financial statements. If it has become virtually certain that an inflow of economic benefits will arise, the asset and the related income are recognized in the financial statements of the period in which the change occurs.

XVII. Explanations on liabilities for employee benefits

As per the existing labour laws and agreements in Turkey, entities are required to pay severance for the employees retired or fired. These payments are qualified as recognized retirement benefit plan according to revised TAS 19 Employee Benefits. Severance payment liability recognized in the balance sheet is calculated according to the net present value of expected amount in the future arising from all employees’ retirements and represented in financial statements. All actuarial losses and gains are accounted for as other comprehensive income.

The major assumptions used in the actuarial calculation are as follows:

Calculation is based on discount rate of 13.50%, inflation rate of 6.00% and real rate of rise in salary of 0.00%.

Effective as of 31 December 2018, ceiling salary amount is considered as 5,434.42 TL (full TL).

Individuals’ earliest retirement age is considered as retirement age.

CSO 1980 mortality table is used for the death probabilities of male and female employees.

There is no employee foundation, fund or similar institutions.

XVII. Explanations on taxation

1. Current Tax

Effective from 1 January 2006, statutory income is subject to corporate tax at 20%, on the other hand as per the provisional article 91 of Law numbered 7061, which is added to Corporate Tax Law numbered 5520 corporate tax rate regarding 2018, 2019 and 2020 fiscal periods (accounting periods starting within the related period for companies which are assigned special accounting period) has been changed as 22%. This rate is applied to accounting income modified for certain exemptions (like dividend income) and deductions (like investment incentives), and additions for certain non-tax deductible expenses and allowances for tax purposes.

If there is no dividend distribution planned, no further tax charges are made. Dividends paid to the resident institutions and the institutions working through local offices or representatives are not subject to withholding tax. As per the decisions no.2009/14593 and no.2009/14594 of the Council of Ministers published in the Official Gazette no.27130 dated 3 February 2009, certain duty rates included in the articles no.15 and 30 of the new Corporate Tax Law no.5520 are revised. Accordingly, the withholding tax rate on the dividend payments other than the ones paid to the non-resident institutions generating income in Turkey through their operations or permanent representatives and the resident institutions is 15%. In applying the withholding tax rates on dividend payments to the non-resident institutions and the individuals, the withholding tax rates covered in the related Double Tax Treaty Agreements are taken into account. Appropriation of the retained earnings to capital is not considered as profit distribution and therefore is not subject to withholding tax.

The prepaid taxes are calculated and paid at the rates valid for the earnings of the related years. The prepayments can be deducted from the annual corporate tax calculated for the whole year earnings.

In accordance with the tax legislation, tax losses can be carried forward to offset against future taxable income for up to five years. Tax losses cannot be carried back to offset profits from previous periods.

In Turkey, there is no procedure for a final and definite agreement on tax assessments. Companies file their tax returns with their tax offices by the end of 25th of the fourth month following the close of the accounting period to which they relate. Tax returns are open for five years from the beginning of the year that follows the date of filing during which time the tax authorities have the right to audit tax returns, and the related accounting records on which they are based, and may issue re-assessments based on their findings.

2. Deferred Tax

The Group calculates and recognizes deferred tax for taxable temporary differences arising between the carrying values of assets and liabilities in the financial statements and their corresponding balances considered in the calculation of the tax base according to the Turkish Accounting Standard 12 (TAS 12) “Income Taxes”.

In accordance with the provisional article, added to Corporate Tax Law, corporate tax, which is 20% for the year 2017, shall be applied as 22% for the profit of company belonging to 2018, 2019 and 2020 fiscal periods. In accordance with this provisional article, 22% tax rate has been calculated for periods, in which the deferred tax assets and liabilities emerges and liabilities are met, while it is calculated by 20% for 2021 and following periods.

Deferred tax liabilities are generally recognized for all taxable temporary differences and deferred tax assets are recognized for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilized. Deferred tax asset was not computed over general loan loss and free provisions according to the circular of BRSA numbered BRSA.DZM.2/13/1-a-3 and dated 8 December 2004.

On the other hand deferred tax calculation has started to be applied over all temporary expected credit losses as per TFRS 9 articles from 1 January 2018. The Bank calculates deferred tax for the possible risk provisions, as well.

As of 31 December 2018, the deferred tax asset is TL 79,351 (31 December 2017: TL 9,504 the deferred tax asset). The deferred tax asset is calculated as the net of taxable and deductible temporary differences.

Deferred tax income/(expense) is recognized within “Deferred Tax expense effect” in the income statement; deferred tax expense for the current period is TL 41,147 (1 January - 31 December 2017: TL 12,770 income). Deferred tax effects of the transactions and events recognized directly in the shareholders’ equity are also recognized directly in the shareholders’ equity which is TL 4,262 income (1 January -31 December2017: TL 1,931 expense). Details regarding the deferred tax asset during TFRS 9 transition are explained in Note XXIV “Explanation on TFRS 9 Financial instruments standard”

3. Transfer pricing

The article 13 of the Corporate Tax Law describes the issue of transfer pricing under the title of “disguised profit distribution” by way of transfer pricing. “The General Communiqué on Disguised Profit Distribution by Way of Transfer Pricing” published on 18 November 2007, explains the application related issues on this topic.

According to this Communiqué, if the taxpayers conduct transactions like purchase and sale of goods or services with the related parties where the prices are not determined according to the arm’s length principle, then it will be concluded that there is a disguised profit distribution by way of transfer pricing. Such disguised profit distributions will not be deducted from the corporate tax base for tax purposes.

As stated in the “7.1 Annual Documentation” section of this communiqué, the taxpayers are required to fill out the “Transfer Pricing, Controlled Foreign Entities and Thin Capitalization” form for the purchase and sale of goods or services conducted with their related parties in a taxation period, attach these forms to their corporate tax returns and submit to the tax offices. Related forms are submitted to tax offices on time.

XIX. Additional explanations on borrowings

The Parent Bank provides resources from domestic and foreign individuals and institutions both by borrowing funds and issuing bills and bonds.

Borrowing instruments are initially measured at acquisition cost and subsequently measured at amortized cost with the effective interest method. In the accompanying financial statements, foreign currency denominated borrowing funds are converted in to Turkish Lira with the Group’s spot foreign exchange buy rates and interest expenses incurred during the period relating to the borrowing funds are recognized in income statement.

XX. Explanations on share certificates issued

None.

XXI. Explanations on bank acceptances and bills of guarantee

Bank acceptances and bills of guarantee are presented within off-balance sheet liabilities as being possible liabilities and commitments. Cash transactions relating to bank acceptances and bills of guarantee are realized concurrently with the customer payments.

As of the balance sheet date, there are no bank acceptances and bills of guarantee recognized as liability against an asset.

The explanations about the transition effects of TFRS 9 presented under “Prior Periods’ Income or (Loss)” in the equity under the scope of this article are given below.

Negative difference of TL 429,329 between the provision for impairment of the previous period of Group and the expected credit loss that is calculated in accordance with TFRS 9 as of 1 January 2018 is classified as "Prior Periods’ Income or (Loss)" under shareholders' equity.

As stated in the Communiqué on "Uniform Chart of Accounts and Prospectus" issued on 20 September 2017, for general provisions (TFRS 9 expected credit loss provisions for Stage 1 and Stage 2 ), recognition of deferred tax assets has started as of 1 January 2018. Within this scope, deferred tax assets amounting to TL 67,455 have been reflected into the opening financials of 1 January 2018 and the related amount has been classified under "Prior Periods’ Income or (Loss)" under shareholders' equity. For the specific provisions (TFRS 9 expected credit loss provisions for Stage 3), which have been recognized due to TFRS 9 transition, deferred tax income amounting to TL 39,277 is also classified under "Prior Periods’ Income or (Loss)" in equity as of 1 January 2018.

XXV. Explanations on prior period accounting policies not valid for the current period

TFRS 9 standard came into effect instead of TAS 39 standard as of 1 January 2018. Accounting policies that have lost their validity with the transition of TFRS 9 are given below:

Explanations on financial assets

1. Financial assets at fair value through profit or loss

1.1 Financial assets held for trading

Financial assets held for trading are recognized at their fair values and any gain or losses resulting from such valuation are recorded in the profit and loss accounts. Interests received during the holding period of such financial assets and the difference between the amortized cost (calculated using internal rate of return) and the acquisition cost are recognized as interest income in the income statement. Gains and losses on sale of held for trading financial assets before their maturity and the difference between market value and amortized cost (calculated using internal rate of return) of such financial as assets are recognized in gains and losses on securities trading under income statement.

1.2 Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are subject to valuation in accordance with fair value principles and profit or losses, emerging as a result of valuation, are recognized under profit/loss accounts.

The Group has determined a portion of its extended credits as financial assets fair value through profit or loss, mentioned in TAS 39 standard. The aforementioned loans have been demonstrated on credits line under “Financial assets at Fair value through profit or loss (net)”.

2. Financial assets Available for Sale

Financial assets available-for-sale, are financial assets other than assets held for trading purposes, investments held-to-maturity and originated loans and receivables. Financial assets available-for-sale are measured at their fair values subsequently.

Interest income of the investments securities available-for-sale; based on the internal rate of return; are included in the income statement. Unrecognized gain/losses derived from the difference between their fair value and the discounted values are recorded in “Marketable Securities Revaluation Reserve” under the shareholders’ equity. In case of disposal, gains/losses recognized under equity are realized and recognized directly in the income statement.

Purchase and sale transactions of securities are accounted for on a settlement date basis.

3. Held to maturity investments

The Bank does not have any held to maturity investments as of 31 December 2017.

4. Loans and receivables

Loans and receivables are financial assets, which are generated by providing funds, goods or services to the debtor.

Loans and receivables are financial assets with fixed or determinable repayment schedules and they are not traded in an active market.

Loans are initially measured at their acquisition cost and subsequently measured at amortized cost calculated using effective interest rate method in accordance with TAS 39 “Financial Instruments: Recognition and Measurement”. Duty charges, transaction fees and other expenses paid for the collaterals of the loans are considered as part of the transaction costs and charged to the customers.

The Group classifies its loans and receivables to related groups by considering the “Communiqué Related to Principles and Procedures on Determining the Qualifications of Banks’ Loans and Other Receivables and the Provision for These Loans and Other Receivables” (“Provisioning Regulation”) published in the Official Gazette No. 26333 dated November 1, 2006 and other regulations and makes special or general provisions according to group, in which the loans and receivables are tracked. On the other hand, deferred tax asset is not allocated over the amount of general loan loss provisions for possible losses in accordance with the circular of BRSA dated 8 December 2004 no. BRSA.DZM.2/13/1-a-3.

II. Explanations on Consolidated credit risk

Credit risk is defined as risks and losses that may occur if the counterparty fails to comply with the agreement’s requirements and cannot perform its obligations partially or completely on the terms set.

The debtors or group of debtors are subject to credit risk limits. The debtors’ or group of debtors’ and industrial risk limitations are monitored weekly. Industry concentration is followed monthly.

Credit risk limits and breakdowns for daily transactions are followed daily. Risk concentrations of off-balance sheet risks are followed by remote and on-site control activities.

Credit worthiness of both commercial loans’ and other debtors are being regularly monitored in accordance with the regulations. By utilizing risk rating models which were developed for these purposes, in case the debtors’ risk level increases, credit lines are readjusted and additional collaterals are received if needed. The necessary documentation for utilized loans is taken in compliance with the related legislation.

In accordance with the Parent Bank’s lending policies, the debtor’s creditworthiness is analysed and the adequate collateral is obtained based on the financial position of the company and the type of loan; such as cash collateral, bank guarantees, mortgages, pledges, bills and corporate guarantees.

There are control limits based on VaR over the positions of the the Parent Bank which are held as futures, option contracts and other similar contracts. The credit risks carried for such instruments are managed together with the risks arising from market fluctuations.

Indemnified non-cash loans are subject to the same risk weight with overdue loans.

The Parent Bank performs foreign trade finance and other interbank credit transactions through widespread correspondent network. Accordingly, the Bank assigns limits periodically to domestic banks, foreign banks and other financial institutions based on review of their credit worthiness.

Within the Bank’s risk appetite policy, the following concentrations are measured. They are presented to the Asset and Liability Committee weekly and to the Risk Committee monthly.

As per Customer Group Concentration, Top 20 corporate debtor’s / risk group’s credit risk sum shall not exceed 35% of the Bank’s total credit risk.

Within the industry concentration, the Bank has set its risk appetite as “reasonable”, not to exceed 10% of total loans per sector except the industries listed below.

Industry	Proportional Limit
Construction	20%
Tourism	10%
Factoring	15%
Wholesale and Retail Business	15%

Within the framework of risk appetite policy, the sum of long-term loans which have a maturity more than 1 year, shall not exceed 45% of the bank’s total loans. This ratio is monitored on a weekly basis at the Asset and Liability Committee and on a monthly basis at the Risk Committee.

The Bank’s largest 100 and 200 cash loan customers compose 55% and 65% of the total cash loan portfolio, respectively (31 December 2017: 49% and 57%, respectively).

The Bank’s largest 100 and 200 non-cash loan customers compose 78% and 89% of the total non-cash loan portfolio, respectively (31 December 2017: 75% and 85%, respectively).

The Bank’s largest 100 and 200 cash and non-cash loan customers represent 53% and 64% of the total “on and off balance sheet” assets, respectively (31 December 2017: 46% and 56%, respectively).

Expected credit loss for total credit risk of the Parent Bank amounts to TL 288,131(Stage 1 and Stage 2) (31 December 2017: TL 70,580).

Position limit on currency risk is determined in line with net general position standard ratio on foreign currency. The Bank does not take foreign exchange and parity risk; transactions are usually hedged. Measurable and manageable risks are taken within legal limits.

As of 31 December 2018, the Group's net long position is TL 193,087 (31 December 2017: TL 92,480 net short position) resulting from short position on the balance sheet amounting to TL 2,327,850 (31 December 2017: TL 1,050,041 short position) and long position on the off-balance amounting to TL 2,520,937 (31 December 2017: TL 957,561 long position). The Group uses "Standard Method" in legal reporting to measure the foreign exchange risk.

## Explanations on consolidated interest rate risk

Interest sensitivity of assets, liabilities and off-balance sheet items are evaluated weekly by considering market developments in the Asset-Liability Committee.

Standard method and Asset-Liability risk measurement methods are used to measure the Bank's interest rate risk.

Measurements by employing the standard method are carried out monthly by using maturity ladder. Bank applies interest rate shock analysis to interest rate sensitive assets and liabilities considering historic economic crisis. Change in the net present value of the net assets of the Bank are monitored within the limits set by the Board of Directors.

V. Explanations on consolidated position risk of equity securities resulted from banking book

The Group has no position risk of equity shares as of 31 December 2018 (31 December 2017: None).

VI. Explanations on liquidity risk and liquidity coverage ratio

The Board of Directors reviews the liquidity and funding risk management policy weekly or in case of necessity. Liquidity risk is managed by Asset and Liability Committee (ALCO) in line with risk management policy as short and long term liquidity risk.

Liquidity Risk is managed by ALCO in order to take the necessary measures in a timely and correct manner against possible liquidity shortages. Treasury department manages cash inflows and outflows in line with strategies determined by ALCO. As deemed necessary by the ALCO members, liquidity meetings are performed for the purposes of close monitoring. Treasury department manages short term liquidity by adhering to the ALCO strategy and ensuring compliance with legal liquidity limits and stress testing.

In the context of TL and foreign currencies liquidity management, the Parent Bank monitors the cash flows weekly and action plan is made based on ALCO decisions. The funding balance is directly monitored and compensated by making the risk-return-cost evaluation.

For long-term liquidity "Maturity Mismatch Report" is prepared and presented to ALCO on a weekly basis. The Group, resulting from the general structure of Turkish banking sector, has a liquidity gap at the 7 month maturity period. The Group intends to eliminate liquidity mismatch shifting focus to long-term funding alternatives. Such decisions of the risk of incompatibility are taken by ALCO. The Group diversifies its funding sources among customer deposits, domestic and foreign borrowings, bills and bonds issued, taking into consideration the maturity match between its assets and liabilities and keeps liquid assets in order to fully meet the liquidity requirements that may emerge in case of market volatility.

Information on the use of stress testing

Department of Risk Management implements stress testing according to Liquidity and Funding Risk Policy approved by the Board of Directors on a weekly basis. These stress tests are based on the scenarios of the deposit outflow, funds obtained from bonds issued will outflow, banks limits will not be used during a 14-day period, the results are included in the presentation of ALCO on a weekly basis and in the Presentation of Risk Committee on a monthly basis. By this way, the Bank's funding structure is closely monitored and actions are taken on behalf of existing risk management.

Alternative funding sources are identified in case of need. ALCO members are responsible for taking actions against short-term liquidity shocks. In the case of a crisis or if deemed necessary, ALCO summon a meeting and take necessary actions immediately. These action plans are approved by the Board of Directors under the İSEDES. The Bank reviews resources that are available in any emergency situation constantly and takes into consideration the results of the above-mentioned stress testing and scenario analysis by the early warning system.

According to BRSA’s “Legislation on Measurement and Assessment of Liquidity Adequacy of the Banks”; published in the Official Gazette numbered 28948, dated 21 March 2014; liquidity ratio is required to be 70% for foreign currency assets/liabilities and 90% for total assets/liabilities in the calculation of the banks’ weekly and monthly reporting effective from 1 January 2018.

As per the related regulation high quality liquid assets are mainly securities portfolio, cash assets and reserve requirements. The important factors affecting the results of the liquidity coverage ratio are the changes in the remaining maturities of the items and changes in the amounts of deposits and money market transactions, the remaining maturities of which are less than 30 days. Deposits form a significant portion of the Bank's sources of funds, on the other hand bonds issued, money market borrowings, funds provided from abroad are other important sources of funding.

The Bank calculates cash flow and margin likely to transactions arising from derivative transactions in accordance with the Regulation on Banks' Liquidity Coverage Ratio dated 21 March 2014 and numbered 28948 published in Official Gazette as taking 24-month average into account. In accordance with the Banking Regulation and Supervision Agency's decision no 7940 dated 07/09/2018, guarantees received for derivative transactions are not included in the calculation of liquidity adequacy ratio, effective from 31 July 2018 until 31 December 2018.

XI. Explanations on risk management objectives and policies

The Bank does not apply any netting on balance sheet and off-balance sheet. Guarantees and derivatives are not used as credit mitigation techniques; but only financial collaterals consisting of cash blockages are used.

Risk Management System refers to the Board of Directors, the Audit Committee, the Risk Management Committee, the Asset-Liability Committee and the Risk Management Department which have been composed in order to manage systemic risks that the Bank is exposed to. The Board of Directors is the owner of the Bank's Risk Management System and ensures the establishment of an effective, sufficient and appropriate risk management system as well as the continuity of the system. The main objective of the Bank's Risk Management System is to identify, measure, monitor and control the risks that the Bank is exposed to, by determining the policies, limits and procedures to control, to monitor, and if necessary to change the risk-return structure of the Bank's future cash flows, the level and the quality of related activities.

As part of the Risk Management System, the Asset and Liability Committee presentation is prepared on a weekly basis and the Risk Committee and the Board of Directors presentations are prepared on a monthly basis. The presentations mainly consist of the Bank's financial statements, profit and loss analysis, credit risk, market risk, liquidity risk, concentration risk, interest rate risk due to banking book, and operational risk as well as the risk that the Bank is currently exposed to or possible risks.

The Board of Directors of the Bank delegated the authorization related to the hedge accounting to The Asset and Liability Committee with the condition of providing regular information. At the same time the Bank has organized credit policies and risk mitigation policies due to credit risk. All processes of the Bank are controlled by the Bank's Internal Control Department's control matrices regularly and are subject to supervision by the Internal Audit Department at the same time.

The Bank uses credit rating models and/or decision trees and rating systems using financial and non-financial data for loan customers as a risk measurement system. Market risk measures are calculated within the scope of the Regulation on Measurement and Evaluation of Capital Adequacy of Banks and using only internal model and market data for intra-bank use. In addition to these, risks are measured and reported with regular stress tests. Three stress tests (base, negative, extremely negative) are performed on a yearly basis, stress tests are performed on a monthly basis for market risk and counter party credit risk, stress tests are performed on a weekly basis for interest rate risk and liquidity risk by Risk Management Department of Bank and then they are shared with senior management in the ALCO and the Risk Committee meetings.

Periodic reports about liquidity risk, interest risk, securities portfolio, credit risk, customer concentration, sectoral concentration, collateral structure and capital adequacy are reported to the Board of Directors and senior management.

Explanation on the differences between the risk amounts and the amounts assessed in accordance with TAS in the financial statements:

Disclosures regarding differences between amounts valued according to TAS and risk exposures

The differences between the amounts assessed under TAS and the amounts after risk reduction in transactions subject to counterparty credit risk stem from the addition of potential risk amounts to the renewal costs of derivative transactions subject to the CPR and the volatility adjustments for repo / reverse repo transactions. Funds provided to differences arising from risk reduction are also included by opening separate line for them.

Valuations of securities subject to market risk in accordance with TAS represent the fair value of held for trading financial instruments. On the other hand, the values in the risk amount line represents the amount subject to market risk based on the capital requirements calculated for the losses arising due factors such as interest rate risk of the market risk, equity price risk, currency risk in accordance with the “Regulation for Measurement and Evaluation of Banks’ Capital Adequacy Ratio”.

If financial instruments that are accounted for at their fair values are traded in an active market, the valuation is based on that market price. The TL borrowing instruments in the held for trading securities portfolio comprise of government securities. These securities are evaluated at the weighted average trading price in the Istanbul Stock Exchange. For TL securities that are not traded, the market price is calculated based on the CBRT prices. For the FX securities in the same portfolio, the average of purchase and sale quotations in the market are considered as the market price. Derivative financial instruments are evaluated using the discounted cash flow model using market data. Input data used in evaluations using market value and/or valuation methods are periodically checked for validity and independence.

Information on Credit Risk

General Qualitative Information on Credit Risk:

The Bank’s credit risk management policies are established in line with the strategy approved by the Board of Directors in accordance with the related regulations and are based on prudence, sustainability and the customers’ credit worthiness principles.

The limits are set in accordance with the Risk Policies by the Board of Directors based on the Bank’s risk appetite. In accordance with the determined risk limits, the authorizations and sub-authorizations are done by the Credit Policies which is in line with the determined limits. Special attention is given to ensure that the limits are in line with market expectations and the Bank’s strategies.

Credit rating models and decision trees are used in the credit underwriting processes in accordance with the risk appetite, credit policies set by the Bank and the targets of the Bank. The grading of all customers except for individual credit customers by the Bank is essential. The individual loan portfolio is managed via an automated decision trees.

Customer selection is carried out in accordance with policies and strategies of the Bank and is based on the ability to pay on time and the cash flows expected to be received from its operations independent from guarantees, sureties and pledged assets. When needed; it is mandatory for the Bank to obtain appropriate collateral in line with the source of the payment for the repayment of the credit from the customers to ensure that their obligations arising from the credit are met on time and in full. The main purpose of collateralization of any loan is to minimize the credit, foreign exchange and maturity risks. In this context, a minimum collateral margin is determined by taking into account the collateral quality and the collection expectations given default and it is ensured that the appropriate collateral is obtained based on the credit type. Before a credit relationship is established with a customer, an analysis and intelligence collection are carried out in order to measure the creditworthiness of the customers. Before the credit decisions; the customer is examined and evaluated with an analysis for factors that have affected its past, present and future performances and any other factors (financial and non-financial data) that may affect its past, present and future performances.

General Qualitative Information on Credit Risk (continued):

Credit risk is encountered when the counterparty is unable to fulfill its obligations defined with the agreement. All credit risk bearing banking products are managed with prudent credit policies and procedures in the Bank. The credit quality of the counterparty is evaluated with an internal rating score in all corporate, commercial and SME credit transactions. In order to monitor the credit risk, internal limits are determined on the basis of sector, maturity, customer and internal rating to avoid the risk of concentration.

Credit risk management is a process in which credit risks are assessed and monitored in a consistent manner, besides all credit portfolios are included on a consolidated basis. Credit risk is managed on the basis of portfolios, risk / return balance and asset quality of the Bank, and the credit risk is governed by the principles contained in the policy documents. In addition, credit-based evaluation, underwriting and follow-up are carried out by the units in the Loans group within the framework of the relevant processes. Loans proposals are evaluated by the credit units of the Headquarters, if necessary, within the framework of the level of authority based on the determined amount and finalized the loan proposal by the Credit Committee and the Board of Directors.

The units carry out their risk management activities in accordance with the risk appetite and capacity of the Bank through the use of risk measurement and management tools within the policies established by the Board of Directors. In this context, the organizational structure for credit risk management and control functions is detailed as follows the units included in the scope of Credit Risk Management are Corporate Loans, Commercial and SME Loans Allocation, Credit Monitoring and Collection Department and Risk Analysis Department. Decisions on credit policies are taken by the Credit Committee. Allocated credit limits and usages, exceeded limits, assessments of large risks and overdue loans are regularly reported to the senior management.

In the course of credit risk management, the Risk Management Department conducts monitoring and reporting of internal concentration limits. It is ensured that the policies related to the concentration risk management are prepared and processed within the policies of allocation, monitoring, limit monitoring and management. Regular reporting on the cost of the loan and the development of the following loans is made. In addition, stress test and scenario analysis studies related to the loan portfolio are carried out within the scope of ICAAP.

The evaluation of the internal systems established to cover all branches and units and the maintenance of the continuity of functioning, competence and efficiency are among the highest priorities of the Bank's Board of Directors. Within the scope of internal systems, the duties and responsibilities of the Board of Directors, Internal Audit, Internal Control and Operational Risk and Risk Management activities are carried out by the Audit Committee.

Information on consolidated credit risk mitigation techniques

The Bank does not apply any netting on balance sheet and off-balance sheet. Guarantees and derivatives are not used as credit mitigation technique; only financial collaterals consisting of cash blockages are used.

Applications related to the valuation and management of collaterals are defined as follows: Appraisals for the mortgages that are received as collaterals are only performed by the firms that have been approved by the BRSA and licensed by the Capital Markets Board (“CMB”). Appraisal reports for the real estates that are received as collaterals for commercial loans, are renewed each year as long as the risk continues. As a rule, each year a different appraisal firm is preferred. Management of the appraisal process is carried out by Appraisal & Real Estate Project Finance Unit. Vehicle pledges are followed through their insurance values. Regular investigations are performed for the cheques and bills that are received as collaterals and in case of any negative finding the Bank seeks to replace the collateral.

The Bank’s collaterals are mainly composed of cheques, notes, mortgages, guarantees, vehicle pledges and deposit pledges. The Bank’s credit risk concentration mainly consists of corporate receivables and are followed by receivables that are collateralized with mortgage, SME and retail receivables, respectively.

Explanations on consolidated market risk

Whether the Group within the financial risk management objectives hedges itself against market risk, the precautions taken by the Board of Directors for market risk, the methods used for measuring market risk and time intervals for measurement of market risk

In order to hedge against the market risk within the context of the risk management objectives, the Group sets its activities related with market risk management in accordance with “Regulations on Banks’ Internal Control and Risk Management Systems” published in the Official Gazette no. 29057 dated 11 July 2014 and “Regulation on Measurement and Assessment of Capital Adequacy Ratios of Banks” published in the Official Gazette no. 29511 dated 23 October 2015.

Being exposed to market risk, Bank’s Board of Directors have defined risk management strategies and policies about risk managements in line with application and recommendation of group and have led to follow-up strategies periodically. The limits of risks are identified and these limits are revised periodically. Board of Directors ensures that risk management group and executive managers should identify, measure, control and manage the Bank’s risk.

Market risk arising from trading transactions is limited through the risk appetite policy approved by Board of Directors as “low” and measured by taking into consideration BRSA’s standart methodology. Additionally Financial Control Department reports the market value and realized profit/loss of trading portfolio.The Risk Management and Asset Liability Committee continously monitor compliance of trading transactions with the risk appetite policy. Market risk caused by mismatches of asset-liability maturities is also monitored through GAP reports.

Stress tests and scenario analysis are also applied in order to reflect the effects of prospective severe market fluctuations in the VaR calculations. Risk measurement methods such as cash flow projections and GAP analysis are also applied.

Capital to be kept for general market risk and specific risk are calculated by using a standard method in accordance with “Measurement and Assessment of Bank Capital Adequacy Regulation” and are reported monthly.

In the calculation of the value at credit risk for the derivative financial instruments, the receivables from counterparties are multiplied by the rates stated in the Article 21 and Appendix-2 of “the Regulation on Measurement and Assessment of Capital Adequacy of Banks”, reduced as per the “Regulation on Credit Risk Mitigation Techniques” following included in the relevant exposure category and weighted for a second time. The risk amount related to the Bank's derivative financial instruments are calculated using the “Fair Value Method”.

The total of replacement cost and potential credit risk make up counterparty risk amount. Counterparty credit risk mitigation considers only cash collaterals.

Value at operational risk amount is calculated by using the last 3 years’ (2017, 2016, 2015) gross income, in accordance with the Communiqué on “Measurement and Assessment of Capital Adequacy of Banks” issued on Official Gazette dated September 6, 2014 numbered 29111, “Calculation of Operational Risk”. 15% of gross income which is TL 89,171 (31 December 2017:TL 71,170) represents also the minimum capital requirement to recover the risk amount.
